## **DESTIN MAN CHARGED WITH VIDEO VOYEURISM AND BATTERY**



The Okaloosa County Sheriff's Office has charged a Destin man with placing a cell phone in a unisex business bathroom to record a patron.

38-year old Huy Doan, who goes by the name "Steve", is charged with video voyeurism and battery causing bodily harm. The victim says she went to Rose Nails at 34940 Emerald Coast Parkway around one p.m. yesterday afternoon to get a pedicure. She told deputies when she asked to use the bathroom Doan told her it was the first door on the left and she went to pick out a nail color before heading to the restroom. She says Doan was exiting the bathroom as she went to go in but she did not hear a flushing sound or water running which she considered "odd".

The victim says when she looked around the restroom she noticed a cell phone sitting in a custom made cardboard holder held together with black tape propped in plumbing under the sink facing the toilet. She took out her smart phone and took two photos of what she observed. The phone's light was on indicating it was recording. The victim took the phone from under the sink, put it in her purse, walked out of the business and called 9-1-1. While calling the OCSO, Doan approached and said, "I'm sorry. It was a mistake, I have a family. I was working on the pipes."

He followed the victim around the parking lot as she tried to get away from him. He then attacked her, placing a hand around her neck to hold her down while he pulled items out of her purse. Once he had the phone, she says Doan walked away and was seen manipulating the phone's controls. A witness who saw the struggle stayed with the victim until deputies arrived. The witness told deputies before they go on scene Doan walked back up to the victim and the witness told him to walk away.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On October 21 2015, at approximately 1300 hours, I was dispatched to the business of, Rose Nails, 3940 Emerald Coast Parkway, Destin, FL, located inside the Best Buy shopping plaza. Upon arrival I met with the victim, [REDACTED] was obviously shaking, breathing very deeply, had very wide eyes, and had a hard time speaking. [REDACTED] had redness, scratches and swelling around her neck and collar bone area. She stated in a video recorded and written statement that, She walked into, Rose Nails to ask if they had time for a pedicure. An Asian gentleman later identified as, Huy Anh Doan, ( Steve) stated they did, and to pick out her nail color from the colors on the wall. [REDACTED] stated she needed to use the bathroom, and Steve said " first door on your left." [REDACTED] then picked out a nail color and then went to use the restroom. As [REDACTED] walked to the single toilet unisex restroom, she observed Steve exiting. [REDACTED] thought it was weird as [REDACTED] just walked down the hall and came out of the bathroom without [REDACTED] hearing a flushing toilet or water running from the sink as if he was washing his hands. [REDACTED] advised me her husband is military and she keeps aware of her surroundings. [REDACTED] entered the bathroom and thought it was odd behavior. [REDACTED] then began to look around before she went to use the restroom. As she looked under the sink, she observed a cell phone sitting in a custom made cardboard holder held together with black tape propped in the plumbing under the sink, facing the toilet. [REDACTED] then took out her smart phone and took two photos of what she observed. The light was on the phone in the cardboard holder indicating

that the phone was on and recording. This is very clearly seen in the photos she took. [redacted] then took the cardboard holder with the phone inside it and put it in her purse and closed the flap on her purse. [redacted] exited the bathroom and calmly walked out the front entrance to the business. [redacted] continued to walk in the parking lot and she called 911. As she was on the phone, Steve came up behind her and uttered, "I'm sorry, it was a mistake, I have a family, I was working on the pipes." [redacted] told Steve to, "back away, no you need to back away, I'm on the phone with the police." Steve followed her for approximately 40 yards as she tried to get away from him walking towards Office Depot. Steve then cornered her in some bushes in the parking lot, where [redacted] could not exit. Steve then lunged at her and [redacted] fell backwards into the grass and bushes. [redacted] approximates for 30-60 seconds she had to fight Steve off. Steve had one hand around her neck and collar bone area holding her down, and his other hand was pulling items out of her purse. [redacted] was kicking and screaming as loud as she could. Both of [redacted] flip flops were thrown off her feet with one going as far behind her as the other parking lot. Steve got the taped cardboard holder with his phone inside, out of her purse and walked eastbound in the parking lot towards Best Buy. A witness( Jennifer Flowers), who saw the entire struggle, approached [redacted] to see if she was ok. A few minutes later Steve was walking back to his nail salon but [redacted] did not observe the taped cardboard holder, Steve was only holding his phone looking at it and manipulating the controls. Steve walked up to [redacted] and Jennifer and Jennifer told Steve she was an attorney and to walk away, he hesitated then entered his business.

My investigation, which is based on statements from the suspect, the independent witness, physical marks and scrapes, along with photographic evidence revealed, Huy Anh Doan, did violate, F.S.S. 784.03.1a2 Battery and F.S.S. 810.145.2a, Video Voyeurism. This incident occurred in Okaloosa County, Florida, where your affiant is a sworn law enforcement officer.
