#### **CRESTVIEW MAN TERRORIZES FAMILY, RESISTS ARREST**



A Crestview man pulled a weapon on family members, strangled one until she passed out, and shoved his 75-year old grandmother to the floor during an ordeal that began following an argument over his desire to shoot a gun out the front door at a home on John King Road around 8 p.m. last night. He later fought with deputies called to the scene to protect the family.

31-year old Mark Alan Dandridge Jr. of 109 Pin Oak Court is charged with three counts of domestic violence related aggravated assault with a weapon, domestic violence related battery, domestic violence related battery by strangulation, battery on a person 65 or older, domestic violence related child abuse without great harm, battery on a law enforcement officer, resisting arrest with violence, and resisting arrest – obstruction.

Deputies say Dandridge punched his 36-year old sister in the mouth, grabbed her by the throat, and strangled until she became unconscious at her home, 362 John King Road. When she came to, she left and took two others to her grandmother's home on Pin Oak Court. They locked themselves inside, however Dandridge followed and got in through the garage. Once in the house, he pushed a juvenile to the ground, along with his sister. Dandridge then shoved his 75 year old grandmother to the floor, raised his shirt and showed them all a firearm and threatened to shoot them. He went outside, slashed the

tires on a car, and headed back to 365 John King Road. He was confronted by two responding Okaloosa County Sheriff's Office deputies.

Dandridge refused to comply with their demands to get on the ground. The deputies moved in and attempted to handcuff him. Dandridge fought, and struck one Deputy in the ribs with his knees while kicking his legs.

They were able to place Dandridge in a patrol car. He was taken to the Okaloosa County Jail in Crestview. Neither deputy was seriously injured.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On the evening of 10-03-15 Deputies responded to 109 E. Pin Oak Court in Crestview, Florida, in reference to a disturbance.

Investigation of the incident revealed the following:

On the evening of 10-03-15 the suspect, Mark Dandridge, and the victims, Jeanne Esterberg, Mandy Keen, n and Deputy Jeremy Gilbert became involved in verbal and physical disturbances at the addresses of 362 John King Road and 109 E. Pin Oa<u>k Cour</u>t in Crestview, Florida. It should be noted Dandridge, Esterberg, M. Keen and are related by blood and do /// together as a family unit.

On the evening of 10-03-15 a disturbance occurred at 362 John King Road between the victim, M. keen and the defendant, Dandridge. M. Keen and Dandridge became involved in a verbal disagreement about Dandridge wanting to discharge a firearm out the front door of the residence identified as 362 John King Road in Crestview, Florida. This confrontation turned physical when Dandridge struck M. Keen in the mouth with a closed fist, which caused M. Keen's lip to bleed. Dandridge further grabbed M. Keen by the throat cutting off her airway, which caused her to pass out and urinate on herself. After she came to, M. Keen took and K. Keen to Esterberg's residence located at 109 E. Pin Oak Court in Crestview, Florida, locking themselves inside the residence. However, Dandridge followed and was able to gain access to the residence using the code to the garage door. Once inside Dandridge pushed identified as a 17 year old juvenile, to the ground. Dandridge then engaged M. Keen again, pushing her to the ground. Dandridge then pushed his Grandmother, J. Esterberg, identified as being 75 years of age, to the ground, Dandridge then raised his shirt, exposing a concealed firearm in the waisfband of his pants and verbally threatened to shoot M. Keen, A. Keen and Esterberg, which caused them to be fearful. Dandridge then exited the residence. Once outside Dandridge pointed the firearm at the windshield of the victim, V. Berry's vehicle, but did not shoot the vehicle. However, Dandridge

did flatten two tires, by cutting the sidewalls, on the vehicle causing an estimated \$200.00 damage to the tires. Dandridge then left the residence in his red pickup and traveled back to 365 John King Road where he was confronted by Deputy J. Gilbert and Deputy R. Kimble. Dandridge, who was on the front porch when Deputy Gilbert arrived, went inside the residence, but emerged from the residence moments later and walked directly towards Deputy Gilbert. Dandridge was refusing Deputy Gilbert's commands to stop and get on the ground. Dandridge continued approaching Deputy Gilbert, until Deputy Gilbert placed Dandridge at Taser point. After a failed Taser deployment Gilbert and kimble attempted to handcuff Dandridge. However, Dandridge continued to be verbally resistant and tensed his muscles resisting Kimble and Gilbert's efforts in handcuffing him. At the point where we were going to transport Dandridge he became combative again trying to pull from Deputy Kimble's grasp, which led to taking Dandridge to the ground in an effort to gain control of Dandridge. Once on the ground Dandridge struck Deputy Gilbert in the ribs with his knee. When attempts were made to restrain Dandridge's feet in a hobble he kicked his feet at Deputies.

It should be noted at the time Deputies Kimble and Gilbert had contact with Dandridge they were dressed in Sheriff's office issued uniforms with Sheriff's Office insignias, patches and badges displayed.

The defendant's actions throughout this incident were witnessed by Trishia Johnson, Darron Adams, Darryl Roberts and

Based upon my investigation, the witness statements, and evidence present, i have reason to believe and do believe the defendant, Mark Dandridge, committed the offenses of domestic battery by strangulation, in violation of F.S.S. 784.041 (2)(a.) cruelty towards child (DOMV.) in violation of F.S.S. 827.03 (2)(c.) battery (DOMV.) in violation of F.S.S. 784.03 (I)(a)(1) batter on person aged 65 or older (DOMV.) in violation of F.F.S. 784.08 (2)(c.) aggravated assault with deadly weapon (DOMV.) in violation of F.S.S. 784.021 (1)(a.) criminal mischief, in violation of F.S.S. 806.13 (1)(b)(2.) resisting an officer without violence, in violation of F.S.S. 843.02, resisting with violence, in violation of F.S.S 843.01, and battery on a law enforcement officer, in violation of F.S.S. 784.07 (2)(b.) These offenses occurred in Okaloosa County, Florida.
