ATTEMPTS TO DEFRAUD ELDERLY HIT ROADBLOCK IN OKALOOSA COUNTY

Two men have been arrested in connection with an effort to defraud local residents through a bogus home repair scheme. The investigation is continuing.

The Okaloosa County Sheriff's Office received a number of calls October 4th and 5th in connection with a suspicious newer model black Dodge pickup truck in areas of Mary Esther and Fort Walton Beach.

A 74-year old Camellia Drive resident in Mary Esther reported three men knocked on her door October 4th and told her a squirrel was damaging a vent on her roof. One of the individuals asked her if she wanted it repaired. After she said yes, he went on the roof and stated he had fixed it. She planned to pay \$35 dollars with a check but they said they only take cash and would come back the next day.

They returned October 5th with an invoice for \$950. She told them to leave. She says an unrelated work crew that came to her home told her no repairs had been done to the roof.

While taking that report yesterday, the deputy overheard a bulletin for three subjects involved in similar suspicious activity. Their vehicle had been spotted near the intersection of Lovejoy Road and Mary Esther Cut-off around 3:20 p.m. A traffic stop was made after the driver failed to signal while making a right hand turn.

It was later learned the driver gave the deputy a false name, was driving on a suspended license, had a stolen tag on the truck, and no insurance.

A search of the truck turned up a bottle of prescription pills that had been taken from the home on Camellia Drive. The homeowner came to the scene and positively identified the trio as the men who had been at her home the day before. The search also turned up an uncashed \$8000 check along with identification and credit cards belonging to an 87-year old female.

At this time, the driver, 24-year old Christopher Frame of Killeen Texas, is charged with grand theft from a person 65 or older, criminal mischief, petty theft, and providing false information to a law enforcement officer.

18-year old Isaac Jones of Texarkana Arkansas is charged with burglary, theft of a controlled substance, possession of a subscription without a prescription, and providing false information to a law enforcement officer.

Currently there are no charges filed against the third individual, who says he had hitched a ride with Frame and Jones in Tyler Texas.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On October 5, 2015 the defendant, Isaac Lee Jones was arrested for Criminal Mischief.

On October 5, 2015 the complainant stated he received a call from the alarm company responsible for monitoring the residence at 914 Pocahontas Dr. The complainant stated he went to the residence and observed a concrete driveway marker had been knocked over and a door to the residence had been forced open. The complainant stated the estimated damage to the door was approximately \$300.00. The complainant completed an affidavit of complaint which I swore him to.

During the same approximate time, I responded to two suspicious vehicle complaints in the same area. The witnesses stated they observed a newer model, black, Dodge Ram, with a Florida tag and loud exhaust was seen pulling into driveways and leaving a short time later. The witnesses stated they observed two white males exit the vehicle and run into the back yards of different residences. The witnesses stated there was a total of three white males in the vehicle.

A vehicle matching the description, given by the witnesses, was observed on Mary Esther Blvd. A traffic stop was conducted and the defendant was identified. A witness in the vehicle stated he observed the defendant get out of the vehicle at the above address and kick the door open. The witness stated he remembered the truck knocking over a cement driveway marker as the vehicle left the above residence.

The defendant did not wish to provide a statement.

Based on my investigation which consisted of interviews with the defendant, the witnesses and the complainant.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On October 5, 2015 a bulletin was issued for a black Dodge 4 door pickup truck that was involved in multiple incidents involving suspicious circumstances in the Mary Esther and Fort Walton Beach Areas of Okaloosa County on October 4 and 5, 2015. Each of these incidents involved 3 males which contacted residents under suspicious circumstances. These incidents specifically are as follows:

OCSO15CAD178934 which occurred at 6 Camellia Drive at 1225 hours (grand theft) OCSO15CAD178999 which occurred at 202 Forest Drive at 1403 hours (suspicious activity) OCSO15CAD179015 which occurred at 1 Tooke Street at 1417 hours (suspicious activity) OCSO15CAD179020 which occurred at 914 Pocahontas Drive at 1423 hours

On October 5, 2015 at approximately 1520 hours being aware of the bulletin I observed a black Dodge 4 door pickup truck at the Chevron Gas Station located at the intersection of Mary Esther Cut-off and Lovejoy Road. This vehicle was occupied by 3 male subjects.

I performed a traffic stop on this vehicle after he failed to signal while making a right hand turn, bearing FL tag DZAW34 at 547 NW Mary Esther Blvd, Fort Walton Beach FL. I then made contact with the driver who identified himself as Shelby Dean Slaton. Slaton did then admit that his Texas drivers license was suspended.

Further investigation revealed the black Dodge pickup truck was taken from an unknown car lot under unknown circumstances and that the Florida tag displayed on the vehicle was stolen from another vehicle therefore the black Dodge pickup truck is an unregistered vehicle.

Investigation also revealed there is no insurance on the vehicle as required by Florida law.

During my questioning of Isaac Lee Jones, while he was lawfully detained, as the front passenger in aforementioned vehicle, he provided me with false information. Jones stated his date of birth was 2/2/1999. While in route to Okaloosa Booking Facility Jones stated that he gave the wrong date of birth and then informed me that his date of birth was actually 2/22/1997.

Based on my investigation and statements of the defendant I have reason to believe Jones did violate FSS 837.055(1) False Information To Law Enforcement During Investigation.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On October 5, 2015, I responded to 6 Camellia Drive, Mary Esther, FL in reference to a citizen contact.

I made contact with the victim, Barbara Zupko, who completed a sworn written affidavit of complaint. On October 4, 2015, the victim, Barbara Zupko, received a knock on her door from the defendant, Shelby Slaton. He was accompanied by the co-defendant, Isaac Jones, and the witness, James Hutchinson. The defendant stated he noticed a squirrel was possibly damaging a vent on her roof, and asked if she wanted it to be repaired. The victim stated yes. The witness got on the roof and stated he'd fixed the roof. The defendant asked for \$35, for repairs made to the roof. The victim did not have cash, so she told the subjects to come back on October 5th. When the defendant and co-defendant returned, the defendant presented the victim with an invoice for \$950, while the co-defendant was present. The victim confronted the defendant, who told her she'd been misquoted. She informed them to leave her house. The defendant took the \$35 and left. The victim had subjects from Emerald Construction do maintenance on her residence, on October 5. They informed her there had not been any repairs done to her roof.

While taking the report, I overheard a bulletin being issued for subjects involved in suspicious activity, similar to the incident I was investigating. The vehicle was located, and a lawful traffic stop was conducted. I responded to the traffic stop location, and asked the victim to respond for a show-up. She positively identified the defendant and co defendant as being the subjects who came to her residence and presented her with an invoice for \$950.

Post-Miranda, both subjects denied their involvement.

The witness admitted to going on the roof and not doing any repairs. He was not present when the defendant and co-defendant returned with the \$950 invoice.

Based on my investigation, I do believe the defendants intended to deprive the victim, who is 74 years old, of 950\$, which is in violation of 812.0145(2c). The defendant, did deprive the victim of \$35, which is in violation of F.S.S. 812.014(3a).

The violation did occur in Okaloosa County Florida where I am a sworn law enforcement officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On October 6, 2015, I executed a search warrant on a 2008 Dodge P/U bearing Florida registration DZAW34. The scope of the search was for documents, prescription pill bottles, and controlled substances.

While searching the vehicle, I located a prescription pill bottle, with a partial label, that contained 29 circular, peach colored pills imprinted with "029." Donna, with the Florida Poison Control Hotline, identified the pills as being Alprazolam (Xanax 0.5 MG) a schedule 4 controlled substance. The pill bottle belonged to Alprazolam (Xanax Jones, and Co-Defendant, Christopher Frame, entered her residence, uninvited, while allegedly checking to see if the repair job they'd done, was holding up. The defendants had not done a repair job on her residence even though they received payment. The subjects were operating the above mentioned vehicle, on October 5th, when they

were arrested for numerous charges. The Co-Defendant was driving the vehicle and the Defendant was occupying the front passenger seat. The prescription pill bottle was located underneath the front passenger seat.

Based on my investigation, I do believe the Defendant entered the occupied dwelling of the victim and committed the crime of theft while inside the dwelling, which is in violation of F.S.S. 810.02(3a), the Defendant deprived the victim of a controlled substance which is in violation of F.S.S. 812.014(2C13) and the Defendant was in possession of a controlled substance without a prescription which is in violation of F.S.S. 893.13(6A). The Co-Defendant entered the dwelling of the victim and committed the crime of theft while inside the dwelling, which is in violation of F.S.S. 812.014(2C13). The Co-Defendant deprived the victim of a controlled substance which is in violation of F.S.S. 812.014(2C13).

The violations did occur in Okaloosa County Florida where I am a sworn law enforcement officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On October 5, 2015 the defendant, Shelby Dean Slaton was arrested for Criminal Mischief.

On October 5, 2015 the complainant stated he received a call from the alarm company responsible for monitoring the residence at 914 Pocahontas Dr. The complainant stated he went to the residence and observed a concrete driveway marker had been knocked over and a door to the residence had been forced open. The complainant stated the estimated damage to the door was approximately \$300.00. The complainant completed an affidavit of complaint which I swore him to.

During the same approximate time, I responded to two suspicious vehicle complaints in the same area. The witnesses stated they observed a newer model, black, Dodge Ram, with a Florida tag and loud exhaust was seen pulling into driveways and leaving a short time later. The witnesses stated they observed two white males exit the vehicle and run into the back yards of different residences. The witnesses stated there was a total of three white males in the vehicle.

A vehicle matching the description, given by the witnesses, was observed on Mary Esther Blvd. A traffic stop was conducted and the defendant was identified. A witness in the vehicle stated he observed the defendant get out of the vehicle at the above address and kick the door open. The witness stated he remembered the truck knocking over a cement driveway marker as the vehicle left the above residence.

The defendant did not wish to provide a statement.

Based on my investigation which consisted of interviews with the defendant, the witnesses and the complainant. I have probable cause to believe and do believe the defendant, Shelby Dean Slaton violated F.S.S. 806.13(1)(b)(2)

On October 5, 2015, I responded to 6 Camellia Drive, Mary Esther, FL in reference to a citizen contact.

I made contact with the victim, Barbara Zupko, who completed a sworn written affidavit of complaint. On October 4, 2015, the victim, Barbara Zupko, received a knock on her door from the defendant, Shelby Slaton. He was accompanied by the co-defendant, Isaac Jones, and the witness, James Hutchinson. The defendant stated he noticed a squirrel was possibly damaging a vent on her roof, and asked if she wanted it to be repaired. The victim stated yes. The witness got on the roof and stated he'd fixed the roof. The defendant asked for \$35, for repairs made to the roof. The victim did not have cash, so she told the subjects to come back on October 5th. When the defendant and co-defendant returned, the defendant presented the victim with an invoice for \$950, while the co-defendant was present. The victim confronted the defendant, who told her she'd been misquoted. She informed them to leave her house. The defendant took the \$35 and left. The victim had subjects from Emerald Construction do maintenance on her residence, on October 5. They informed her there had not been any repairs done to her roof.

While taking the report, I overheard a bulletin being issued for subjects involved in suspicious activity, similar to the incident I was investigating. The vehicle was located, and a lawful traffic stop was conducted. I responded to the traffic stop location, and asked the victim to respond for a show-up. She positively identified the defendant and co defendant as

----being the subjects who came to her residence and presented her with an invoice for \$950.

Post-Miranda, both subjects denied their involvement.
