

Following the conclusion of the service, the procession is expected to begin at one p.m. and will travel to The Boardwalk on Okaloosa Island.

The route from out of NWFSC is:

Turn Left onto College Boulevard
Turn Right onto N. Palm Boulevard 0.7 Miles
Turn Right onto SR-285 (Partin Drive) 0.6 Miles
Turn Right onto SR 20 (John Sims Parkway) 1.4 Miles
Turn Right onto Highway 85 (Government Avenue) 12.1 Miles
Turn Left onto US Highway 98 (Miracle Strip Parkway) 1.3 Miles


