SCHOOL RESOURCE OFFICER ARRESTS STUDENT WITH LOADED GUN ON CAMPUS

The Okaloosa County Sheriff's Office has charged a student at Fort Walton Beach High School with possession of a weapon on school grounds.

School Resource Officer Deputy James Reeves says he received a call from a school administrator today informing him a student on campus was in possession of a loaded firearm and intended to commit suicide with the weapon.

The teen was immediately removed from his classroom and relocated to an administrator's office where he admitted he had a loaded firearm in his backpack.

Deputy Reeves found a black revolver loaded with four rounds.

The 17-year old student was charged with possession of a firearm on school property and remanded to the custody of the Department of Juvenile Justice.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 9-25-15 I was working as the School Resource Officer for the Fort Walton Beach High School, located at 400 Hollywood Blvd, Fort Walton Beach, Okaloosa County, FL.

While on duty and during school hours, I received a call from an Administrator informing me a student, [REDACTED] was on campus, in class, and was in possession of a loaded firearm. The administrator further added the student had planned on committing suicide using the firearm.

Contact was made with [REDACTED] For safety of students and staff he and his possessions where immediately removed from the class room and relocated to an Administrator's office.

Once inside the office an Administrator asked [REDACTED] if had anything in his backpack he was not supposed to have. [REDACTED] admitted he had a loaded firearm in his backpack.

I asked [REDACTED] which pocket the gun was in. He told me the second one. I conducted a search of his backpack and found a loaded firearm in the second pocket as described.

The firearm was a black in color finished Ruger revolver pistol. It was loaded with 4 live rounds.

Fort Walton Beach High School is a county public school located at 400 Hollywood Blvd, Fort Walton Beach, Okaloosa County, FL.

Based on the investigation the defendant, [REDACTED] did violated F.S.S. 790.115(2b) – Possession of Firearm on
