SEPARATE SEARCH WARRANTS NET DRUGS, CASH, AND WEAPON

The Okaloosa County Sheriff's Office Narcotics Unit executed two separate search warrants today, leading to the arrests of two men on multiple charges.

23-year old Jordan Gamble of Mary Esther was arrested at his home at 712 Hollywood Boulevard after investigators located drugs, a weapon, and nearly six-thousand dollars in cash inside.

Gamble is charged with Possession of Marijuana with Intent to Distribute, Possession of a Firearm by Convicted Felon, Possession of a Controlled Substance (Ecstasy) and Possession of Drug Paraphernalia.

Marsh was arrested for Possession of Marijuana with Intent to Distribute within 1000 feet of a municipal park, Possession of a Controlled Substance (Cocaine) and Possession of Drug Paraphernalia.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]								

On August 28, 2015, Judge Grinsted reviewed, approved, and signed a search warrant for Jordan Anthony Gamble's residence, located at 712 Hollywood Blvd, Mary Esther, Florida.

On September 3, 2015, members of the Okaloosa County Sheriff's Office Narcotics Unit executed this search warrant.

During the search of the residence, over 250 grams of marijuana, sandwich bags, digital scales, a large amount of money, and a firearm, were located inside of Gamble's bedroom. The marijuana later field tested positive for the presence of THC.

Also located inside of Gamble's bedroom, were 10 pills with a dolphin emblem on them. A field test was conducted of the pills, which rendered a positive result for MDMA, which is a scheduled I controlled substance, per Chapter 893 of the Florida State Statues.

During a post Miranda interview, Gamble admitted to being in possession of a small amount of marijuana inside of his bedroom. Gamble also admitted to the firearm, which was located inside of his bedroom.

During a criminal history check of Gamble, it was confirmed that he was convicted of a felony offense (possession of over 20 grams of marijuana) on April 8, 2013 in Okaloosa County, Florida.

My investigation, which is based on statements from the suspect, witnesses, and collection of physical evidence, revealed Jordan Anthony Gamble did violate F.S.S. 893.13(1a2) - Possession of Marijuana with intent to distribute, 893.13(6a) -Possession of a controlled substance (MDMA), F.S.S. 790.23(1a)- Possession of a firearm by convicted felon, and F.S.S. 893.147(1)- Possession of drug paraphernalia. This incident occurred in Okaloosa County, Florida.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On September 3, 2015, your Affiant obtained a lawful narcotics search warrant for the residence located at 10 Azalea Drive, Mary Esther, Okaloosa County, Florida. The occupant of this residence is identified as defendant, Michael Alan MARSH. This search warrant was reviewed and approved by Assistant State Attorney Angela Mason. This search warrant was read and signed by Judge Patricia Grinsted.

During a search of the residence, Law Enforcement officers located and seized the following contraband:

- -Approximately one hundred eight (108) grams of suspected marijuana. The suspected marijuana field tested positive for the presence of THC.
 - -Packaging material consisting of Ziploc style bags.
 - -Digital scale containing marijuana residue which field tested positive for the presence of THC.
 - -Approximately less than 1/2 gram of cocaine which field tested positive for cocaine.
 - -Marijuana smoking pipe containing marijuana residue which field tested positive for the presence of THC.

This aforementioned residence is located directly across the street from Azalea Park (5 Azalea Drive, Mary Esther, Florida) which is a municipal park within the city of Mary Esther, Florida.

MARSH was advised of his Miranda rights, which he waived, requesting to speak to your Affiant. MARSH stated that everything located above belonged to him and no one else.

Based on the above information, your Affiant has reason to believe and does believe Michael Alan MARSH did commit the following offenses: Possession of marijuana with the intent to sell within a 1000 feet of a municipal park, possession of a a controlled substance (to wit: Cocaine), and possession of drug paraphernalia. These offenses are in violation of F.S.S. 893.13.1c2, F.S.S. 893.13.6a, and F.S.S. 893.147.1 These offenses did occur in Okaloosa County.
