WOMAN WITH SUSPENDED LICENSE, EXPIRED TAG, AND CONCEALED CRACK PIPE CAUGHT AFTER RUNNING STOP SIGN



A woman in a hurry to find her cell phone ended up in the Okaloosa County jail instead after she was pulled over by an Okaloosa County deputy for running a stop sign and having an expired tag.

The 60-year old driver, Claudia Quillian of Panama City, gave the deputy a false name and fake social security number after the traffic stop Saturday night on Legendary Drive in Destin.

Once Quillian's true identity was determined, the deputy also learned Quillian had three prior convictions for driving with a suspended or revoked license in Georgia and Florida. She found marijuana lighters, and burnt brillo pads which tested positive for cocaine, inside the vehicle.

When booked into the Okaloosa County jail, employees discovered a crack pipe concealed in Quillian's privates. It also tested positive for cocaine. Quillian is charged with providing a false name and social security number, possession of pipe making equipment, possession of marijuana, driving with a suspended license with three prior convictions, introduction of contraband to a detention facility, and possession of paraphernalia.

In addition, due to other items located in Quillian's car, the investigation is continuing.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 15, 2015 I stopped a silver Mazda sedan for an expired tag which expired February 17, 2015. Upon stopping, the driver, later identified as defendant Claudia Diane Quillian, provided the name of Claudia Leah Bryson with date of birth 04/25/1954 and a social security number which was false. Quillian has three prior convictions for driving while license suspended or revoked in Georgia and Florida. Quillian stated her license was valid out of Georgia with the

false name. A check of DHSMV confirmed the suspended Georgia driver's license.

Post Miranda Quillian stated there was a purple bag in the vehicle which had marijuana inside but it belonged to her fiance. She also stated her fiance has been in prison for the past three weeks and knew about the marijuana being in the vehicle. The purple Crown Royal bag containing the Marijuana (1gram) was found under the front of the passenger seat. Also inside the bag were lighters and brillo pads pulled apart. Inside the center dash compartment were burnt brillo pad pieces and a broken pen. The marijuana field tested positive for THC. The burnt brillo pad's were tested and showed a positive reaction for the presence of cocaine.

Based upon the above stated facts I have reason to believe and do believe defendant Claudia Diane Quillian violated F.S.S. 901.36.1 by providing false name, date of birth, and social security number. F.S.S. 893.147.1 possession of pipe making equipment and brillo pad pieces. F.S.S. 893.13.6b possessing 1 gram of Marijuana and F.S.S. 322.34.2c Driving with suspended driver's license with three prior convictions. The above offenses occurred in Okaloosa County

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 16, 2015 defendant Claudia Diane Quillian was transported to Okaloosa County Jail after arrest.

During the initial traffic stop of driving with expired tag 6 months or less Quillian was placed under arrest for providing a false name to law enforcement. After arrest she was taken to the vehicle and on video asked if she had any contraband on her. She was asked if she had any narcotics or other property that she could not bring into a booking facility or jail and she stated she did not. I then performed a pat down of the defendant. Sgt. Abbott also asked if she had any contraband on her person and she stated she did not. A female deputy performed a search of Quillian and nothing was discovered.

While at Okaloosa County Jail corrections officer Bova performed the search and found a pipe in the defendants vagina. The pipe was removed and placed into evidence.

The pipe was brought back to Okaloosa County Booking where I field tested it for Cocaine. The field test came back positive.

Based upon the above stated facts I have reason to believe and do believe the defendant, Claudia Diane Quillian violated F.S.S. 951.22(2) and F.S.S. 893.147(1) by possessing drug equipment and bringing it into a detention facility. The above
