[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 8/18/15 the defendant, Patrick Dunn, did willfully violate F.S.S. 893.13.6a Possession of a controlled substance F.S.S. 893.147 possession of drug paraphernalia and F.S.S. 322.34.2b DWLSR 2nd conviction.

On the above date I conducted a traffic stop on a black Honda Civic bearing FL tag 7532QJ. Upon contact with the driver and only occupant, Patrick Dunn, he advised he did not have a license. During the stop, I requested consent to search the vehicle, which was granted by Dunn.

During the search of the vehicle I located a backpack in the back seat of the vehicle. In the pack back was a small silver flashlight. Inside the flashlight battery compartment I did locate a clear plastic bag with a clear crystallized substance inside (suspected Methamphetamine ). In a sperate compartment of the bag was a black digital scale with a white residue on it as well as a short cut plastic straw which was used to ingest the suspected Methamphetamine.

Post Miranda, the defendant admitted that the above contraband and the backpack was his. The suspected Methamphetamine field tested positive and weighed approximately 1 gram.

A check through D.A.V.I.D. showed the defendant's license is currently suspended and also showed a prior conviction.

Based on the above information I have reason to believe and do believe the defendant, Patrick Dunn, did willfully violate F.S.S. 893.13.6a Possession of a controlled substance F.S.S. 893.147 possession of drug paraphernalia and F.S.S. 322.34.2b DWLSR 2nd conviction. These offenses occurred in Okaloosa County, FL.
