[STATEMENT OF PROBABLE CAUSE / NARRATIVE] ····

On 7/25/2015, the defendant Devon Moore who is 16 years of age did commit the following offenses in violation of Florida State Statutes 810.02(2)(B); Burglary to occupied dwelling while armed, 812.014(2)(C)(1); Theft is \$300 or more but less than \$5,000, 790.01(2); Possession of concealed firearm, 812.014(2)(C)(5); Grand theft of firearm, 812.014(2)(C)(6); Attempted Grand theft of motor vehicle, and 790.22(3); Possession of firearm under 18 years of age. Facts to support probable cause are as follows:

At 0236 hours, OCSO Dispatch received a 911 call for a possible burglary to a residence in progress at 1578 Lena Street, Baker. The victim advised per sworn affidavit of complaint on the above date she was inside her home and heard the garage door to her residence opening. She heard voices and noises coming from within her garage. She went to wake her husband up and called 911. The victim then advised she went to her front door and saw a newer model Kia turn around in the street in front of her residence and also observed a older model small pickup truck drive down her street. She then noticed flashlights shining from the street and then saw a tall skinny male with a white t-shirt walking toward her garage. The victim then advised her husband saw someone running from their garage carrying something. She advised the male put the items in the back of the truck and then got into the truck.

I arrived on scene and observed a vehicle matching the description given as well as two black males standing next to the bed of the truck. This was approximately six houses away from the victim's residence. One male was wearing a white t-shirt matching the description given and the other male was wearing a blue shirt and tan pants. Both males were detained for the remainder of the investigation. In plain view in the bed of the truck, I observed a black pelican case and another black case sitting in the back seat of the truck. Moore was read Miranda Warning and advised he would speak with me.

A check of Moore's name was conducted through OCSO Dispatch which revealed he had an active warrant for Grand Theft of a Motor Vehicle. A search of Moore's person yielded he was in possession of a North American Arms .22 magnum revolver (serial number VT08939) concealed in his pants pocket. This firearm was listed as stolen during a vehicle burglary in Pensacola on 7/17/15. Moore advised he got the gun out of one of the cases which were from the victim's residence, which was not consistent with the evidence. When asked where he got the two cases from he advised he took them from the garage of the above listed residence. The gun cases were identified as a Civilian black long gun case, Pelican black gun case which contained a paint ball marker (gun) with electronic hopper. The victim advised there was also electronic garage door opener taken from within his vehicle. When asked how he got into the garage, Moore advised the garage was not shut all the way so he was able to roll under it and then open the garage. Moore advised me while in the garage he was looking for the keys to the vehicle because he was going to steal the victim's vehicle.

The victim identified the gun cases and paintball gun as stolen from within her residence and they were valued at greater than \$300. A show up was conducted and the victim identified Moore the male running away from her garage with the stolen items.

Theses offenses did occur in Okaloosa County, Florida.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On July 25, 2015, I responded to 5139 Blue Springs Cove, Baker, in reference to a burglary. Upon arrival, the victim, Debra Lorinczy, advised at approximately 0930 hours on this date, she found a four-wheeler missing from the porch area of her home.

Lorinczy advised she was informed by a neighbor of burglaries in the area. When she and her husband went outside, she noticed the Yamaha four-wheeler missing that had previously been parked next to the porch; on the curtilage of the home. It was later found to be pushed into the woods approximately 300 feet from the home. The wiring was damaged in a manner that was consistent with someone attempting to start the four-wheeler by bypassing the ignition.

There was Polaris four-wheeler that had been parked in the same location. It was found pushed to near the roadway.

Inspection of her 2005 Honda van, bearing Florida Tag 5417PS, revealed the vehicle had been ransacked, and a plastic zip-loc style bag containing approximately \$15.00 in change had been stolen. Inspection of her husband's 2000 Chevrolet truck, bearing Florida Tag 857QID, revealed the vehicle had been ransacked, but nothing was missing. Lorinczy completed a sworn Affidavit of Complaint in reference to this incident.

The suspects, NKOSI STEPHEN SEALS and Devon Marcus-Ali Moore, were identified from an incident that occurred earlier in the morning. During that incident, SEALS was the driver of a vehicle identified as a suspect vehicle from a burglary. Moore was also in the vehicle and was found to be in possession of a stolen firearm. During a post-Miranda interview stemming from that incident, which was only a few miles from this incident, SEALS and his ca-defendant Moore, admitted to this crime. Moore also admitted to possessing a firearm, which he stole during a burglary in Escambia County, Florida, while committing this crime. SEALS admitted to acting as a getaway driver. Moore also admitted to stealing a four-wheeler.

Upon his arrest, Moore was found to be in possession of a Yamaha ATV key; which was later determined to fit the victim's Yamaha four-wheeler. A plastic zip-loc style bag of change was also found in the getaway vehicle.

Based on the above stated facts and investigation, I find probable cause to believe NKOSI STEPHEN SEALS was principal to the violation of FSS 810.02.2b Armed Burglary to a Dwelling, FSS 810.02.2b Armed Burglary to a Conveyance- 2 counts, FSS 812.014.2c6 Grand Theft of a Motor Vehicle-2 counts, FSS 812.014.3a Petit Theft and FSS 806.13.1b1 Criminal Mischief Not More than \$200.00. These offenses occurred in Okaloosa County, where I am a sworn deputy.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 7/25/2015, the defendant Nkosi Stephen Seals did commit the following offenses in violation of Florida State Statutes \$10.02(2)(B); Accessory to Burglary to occupied dwelling while armed, \$12.014(2)(C)(1); Accessory to Theft is \$300 or more but less than \$5,000, \$12.014(2)(C)(6); Accessory to Attempted Grand theft of motor vehicle. Facts to support probable cause are as follows:

At 0236 hours, OCSO Dispatch received a 911 call for a possible burglary to a residence in progress at 1578 Lena Street, Baker. The victim advised per sworn affidavit of complaint on the above date she was inside her home and heard the garage door to her residence opening. She heard voices and noises coming from within her sarage. She went to wake her husband up and called 911. The victim then advised she went to her front door and saw a newer model Kia turn around in the street in front of her residence and also observed a older model small pickup truck drive down her street. She then noticed flashlights shining from the street and then saw a tall skinny male with a white t-shirt walking toward her garage. The victim then advised her husband saw someone running from their garage carrying something. She advised the male put the items in the back of the truck and then got into the truck.

I arrived on scene and observed a vehicle matching the description given as well as two black males standing next to the bed of the truck. This was approximately six houses away from the victim's residence. One male was wearing a white t-shirt matching the description given and the other male was wearing a blue shirt and tan pants. Both males were detained for the remainder of the investigation. In plain view in the bed of the truck, I observed a black pelican case and another black case sitting in the back seat of the truck. Moore and Seals were read Miranda Warning and advised they would speak with me.

A check of Moore's name was conducted through OCSO Dispatch which revealed he had an active warrant for Grand Theft of a Motor Vehicle. A search of Moore's person yielded he was in possession of a North American Arms ,22 magnum revolver (serial number VT08939) concealed in his pants pocket. This firearm was listed as stolen during a vehicle burglary in Pensacola on 7/17/15. Moore advised he got the gun out of one of the cases which were from the victim's residence, which was not consistent with the evidence. When asked where he got the two cases from he advised he took them from the garage of the above listed residence. The gun cases were identified as a Civilian black long gun case. Pelican black gun case which contained a paint ball marker (gun) with electronic hopper. The victim advised there was also electronic garage door opener taken from within his vehicle. When asked how he got into the garage, Moore advised the garage was not shut all the way so he was able to roll under it and then open the garage. Moore advised me while in the garage he was looking for the keys to the vehicle because he was going to steal the victim's vehicle.

Seals advised me he was contacted by Moore to come pick him up because he just "scored a lick" which Seals identified as going into homes or cars and stealing items. Once he arrived to pick up Moore, Seals advised Moore to put the items into his vehicle. While in the vehicle, Seals advised Moore brandished the firearm, however, Seals advised he did not know where Moore got it from. Seals also advised he saw Moore coming from within the victim's vehicle but did not know if he took anything from the vehicle.

The victim identified the gun cases and paintball gun as stolen from within her residence and they were valued at greater than \$300. A show up was conducted and the victim identified Moore the male running away from her garage with the stolen items.

Theses offenses did occur in Okaloosa County, Florida.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 07/25/2015 at approximately 0240 hrs, I responded to the intersection of Lena Street and Dottie Street, Baker, FL, regarding a burglary to an occupied residence. Prior to my arrival, D/S Z. Putnam stopped a vehicle matching the description of a vehicle fleeing the scene of the burglary.

Upon arrival, I was requested by D/S Z. Putnam to conduct a walk around "Free Air Sniff" of the suspect vehicle with my assigned trained/certified narcotics canine.

Upon talking to the Defendant, Nkosi Stephen Seals, he gave this Deputy verbal permission to turn his running vehicle off and remove his keys from the vehicle prior to me and my canine conducted a walk around of his vehicle. As I entered his vehicle to shut the vehicle off and remove the keys, I smelt a strong odor of burnt marijuana inside the vehicle along with a digital scale and marijuana residue on the driver's seat, and marijuana residue on the floor boards. No other finding within the vehicle.

During a search of Seal's person, I found a cellophane wrapper tucked inside his left sock at the ankle. The cellophane wrapper contained less than one (1) gram of suspected marijuana and one and a half (1.5) pills with pharmaceutical marking (G3722.) The suspected marijuana later yielded positive for THC utilizing a Field Chemical Test Kit. The pills were identified by using Drugs.Com and were identified as Alprazolam 2mg (Schedule IV Narcotic.)

Post-Miranda, Seals stated he did not have a prescription for the Alprazolam.

Based on my investigation and the evidence provided, I believe the Defendant, Nkosi Stephen Seals did violate F.S.S. 893.13.6a, (Possession of a Controlled Substance Without a Prescription), F.S.S. 893.13.6b, (Possession of Marijuana Not More Than 20 Grams), and F.S.S. 893.147.1, (Possession of Drug Paraphernalia). This offense did occur in Okaloosa County, Florida.
