This vehicle was discovered at the American Best Value Inn located at 4255 S Ferdon Blvd, Crestview, FL 32536. Surveillance was set up on the vehicle, and the process of obtaining a search warrant for the vehicle was begun. The defendant exited the hotel and entered his vehicle, he was subsequently detained. He made several spontaneous utterances while he was detained. He stated he had firearms in the vehicle namely a glock pistol and a rifle. He also stated he had marijuana. The search warrant was obtained from the Honorable Judge Ward. During the search of that vehicle three firearms were discovered. A Smith and Wesson Model 422 .22 caliber S/N TDK0150, a Glock 17 9MM s/n HUX486, and a Fab Defense MWG .223 -5.56 rifle.

A review of the criminal history of the defendant showed that due to a non expiring domestic violence injunction that was served May 21, 2010 he is prohibited from possessing or purchasing a firearm.

In a subsequent interview with the defendant he confessed that he had marijuana in his hotel room. He consented to a search of his hotel room located at the American Best Value Inn, 4255 South Ferdon Blvd, Crestview FL room number 122. During a search of the hotel room approximately 29 grams of a green leafy substance that field tested presumptive positive as marijuana and a small baggie containing less than one gram of a white powdery substance that tested presumptive positive for methamphetamine.

Based on the above stated facts I have reason to believe and do believe the defendant Glenn David Winstead violated FSS 741.31.4b. violation of Domestic violence injunction, FSS 893.13.6a Possession of over 20 grams of Marijuana, and FSS 893.13.6a Possession of Methamphetamine. These offenses occurred in Okaloosa County where I am a sworn Investigator with the office of the Sheriff.
