[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 19 December 2015 at approximately 1808 hours, I responded to a Lewd and Lascivious complaint at Children in Crisis, 1000 Lukes Way, Fort Walton Beach, Okaloosa County, FL. The victim [REDACTED] female. My investigation revealed that the victim disclosed to her friend [REDACTED] suspect had tickled her breasts and put his hand down her pants [REDACTED] who then told Michael (suspect) and [REDACTED] confessions.

When confronted with the allegation, the suspect departed to his bedroom and Susan followed him. She asked him, "Did it happen? Did you do it?" The suspect stated "yes" and that he had apologized to [REDACTED] and begged their forgiveness.

I took a Sworn Affidavit of Complaint from the suspect's wife, Susan Kim Hellen, who was the reporting person. While conducting the investigation, the suspect walked into the house and said I will be in the back room. D/S Grundin went to the back room and asked the suspect if he wanted to talk to him. The suspect stated yes, and sat on one side of the bed and D/S Grundin sat at the other end of the bed. The suspect was not detained at this time and was free to stop talking and leave at any time. D/S Grundin asked the suspect if he knew why the sheriff's office was there.

The suspect immediately started confessing to D/S Grundin that while [REDACTED] with the victim, he started rubbing the victim's leg with his hand and he then moved his hand up and started rubbing the victim's vagina through her night pants that came down to her ankles. The suspect stated he asked the victim if she was ok and stated, "I thought she
