[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On January 28, 2016 the defendant, Kevin Brundidge, arrived at the incident location, 1185 Forest Heights Rd Apartment 10, Fort Walton Beach FL. The defendant knocked on the front door. The victim, Dominick Jones, was outside at the time and approached the defendant from the side of the residence. The defendant was known to the victim and followed the victim to the rear of the residence. Once at the back door the victim temporarily stepped in his residence and the defendant attempted to follow him while pointing a pistol at the victim's head. The defendant began telling the victim not to say anything and attempted to close the back door after stepping inside. The victim attempted to disarm the defendant which caused them to get into a physical altercation on the ground. During the altercation the defendant fired the pistol and hit the victim on the right elbow in an attempt to gain control of the pistol.

The victim had teeth marks on his right elbow and stated during the incident he was in fear for his life.

Once detained the defendant refused to provide his name, even after numerous attempts.

Further investigation revealed the defendant had been convicted of several felonies.

Based on the evidence of my investigation I have reason to believe and do believe the defendant, Kevin Brundidge violated F.S.S. 784.045(1a2); Aggravated Battery, F.S.S. 790.07(2); Use of a Firearm During the Commission of a Felony, F.S.S. 790.23 (1a); Possession of a Firearm by a Convicted Felon, F.S.S. 812.135 Robbery Residential Home Invasion, 843.02 Resist Officer Obstruct Without Violence. These offenses occurred in Okaloosa County Florida where I am a Sworn law enforcement officer.
