[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On January 21, 2016, members of the Okaloosa County Sheriff's Office Narcotics Unit, executed a search warrant at 505 23rd Street Lot 2, Niceville, Okaloosa County, Florida.

During a search of the residence a marijuana smoking pipe was located on the coffee table in the living room. The residue in the pipe did field test positive for THC. Marijuana was also located in the bedroom identified as belonging to the Defendant, Chasity C. Powell, and Co-defendant Cleavon Stribling. The marijuana located in this room was found to weigh approximately 2 grams and did field test positive for THC.

Post Miranda, the Defendant admitted to being a marijuana smoker. The Defendant admitted to knowledge of the marijuana in the shared bedroom and admitted to using the pipe which was located in the living room for smoking marijuana.
