On January 24, 2016 at approximately 2057 hours, the Okaloosa County Sheriff's Office responded to [REDACTED] in Destin, Florida in reference to a lewd and lascivious act on a child.

Upon Okaloosa County Sheriff's Office Deputies arrival they met with [REDACTED] the parents of the victim.

The [REDACTED] reported a family friend, Tristan L. Sanders, took their [REDACTED] old son, [REDACTED] for a ride in his 2014 Dodge Challenger. Sanders is a family friend, known to them for approximately eight months, and came over to their house located at the aforementioned address for [REDACTED]. After playing video games with [REDACTED] Sanders offered to take [REDACTED] for a ride in his car because [REDACTED] liked his car. They stated Sanders left with [REDACTED] in between 1630 hours and 1700 hours. After some time had passed, they felt that [REDACTED] had been gone for quite a while. [REDACTED] called Sanders by phone at approximately 1736 hours and Sanders told her they were playing Xbox at his apartment. [REDACTED] told Sanders that [REDACTED] had school the next day and needed him home. Sanders told [REDACTED] that he would have [REDACTED] back before 1900 hours. Around 1900 hours, Sanders brought [REDACTED] back to his residence. After arriving, [REDACTED] went straight to his room and Sanders sat on the couch in the living room for about thirty minutes with the rest of the family. Sanders left shortly thereafter. As soon as Sanders left, [REDACTED] came out of his room and asked his parents if they would be upset if he told them what really happened at Sanders' apartment. The parents told him that it was okay to tell them and [REDACTED] broke into tears as he told them the following events.

During the discovery interview with [REDACTED] he advised, Sanders took him back to his apartment to play video games on an Xbox system. The Xbox system was in Sanders' living room. After some time, Sanders invited [REDACTED] into his bedroom. While in the bedroom, Sanders told [REDACTED] that he wanted him to pull down his shorts so he could pour water in or on his butt. He told [REDACTED] that he wanted to make a video of the "medical procedure" for a medical class he was taking. [REDACTED] said he pulled down his shorts, but then had a weird feeling about it and immediately pulled them back up. After [REDACTED] pulled his shorts back up, Sanders began to offer him money and offered to pay for [REDACTED] PlayStation Network account subscription fees in exchange for [REDACTED] allowing him to do this. [REDACTED] sat on Sanders' bed crying and stating he didn't want to do what Sanders had asked of him. Sanders asked him, "What would make you do this?" [REDACTED] told him he didn't want anything he just wanted to go see his parents. Sanders then took [REDACTED] home. On the way to [REDACTED] house, Sanders told [REDACTED] not to tell his parents. [REDACTED] asked him, "Why?" Sanders said, "It doesn't need to be talked about in public." [REDACTED] said Sanders did not touch him during the encounter.

On January 25, 2016, a forensic interview was performed on [REDACTED] at the Children's Advocacy Center in Niceville, Okaloosa County, Florida. During the forensic interview [REDACTED] advised the following. [REDACTED] stated he went for a ride in Tristan Sanders grey Charger. Sanders took [REDACTED] to his apartment. [REDACTED] only could remember the apartment was on the third floor. [REDACTED] and Sanders began playing video games. During this time Sanders asked [REDACTED] to help him with a medical project for college. Sanders told [REDACTED] that he needed to video tape the project and send it in. [REDACTED] stated he did not want to help but later agreed to go into Sanders bedroom because Sanders kept asking for his help. While in the bedroom Sanders told [REDACTED] he need [REDACTED] to get on the bed with his pants down in the "doggie position". When asked to describe the position [REDACTED] stated he was on his hands and knees with back towards the ceiling. Sanders explained to [REDACTED] he was going to insert warm water into his butt. [REDACTED] stated he got on the bed took off his pants with his underwear still on and got into the "doggie position". At this time Sanders moved [REDACTED] legs apart explaining what he was going to do. [REDACTED] then became scared and pulled up his pants and began to cry. Sanders then attempted to bribe [REDACTED] with money. Sanders offered [REDACTED] from twenty (20) dollars to fifty (50) dollars as well as to pay for his video game online fees for [REDACTED] to continue. [REDACTED] told him no and began to cry and asked to be taken home. Sanders then took [REDACTED] home and while in the vehicle going home Sanders told [REDACTED] not to tell anyone. When [REDACTED] asked Sanders "why?" Sanders told [REDACTED] "the public did not need to know".

During the interview [REDACTED] was asked to describe the bedroom. [REDACTED] stated the bedroom had a bed and he remembered a television and computer which was running facing the bed. [REDACTED] stated he remembered seeing a game on the computer called "Happy Wheels" on the computer and a person's face in the corner of the screen. [REDACTED] stated he did not recognize the person and was not sure if the person could see him. [REDACTED] also remembered a large bucket filled with what he believed to be warm water with a sticker all around the bucket.

Based on the aforementioned information I have reason to believe and do believe Tristian Lee Sanders did violate Florida State Statute 800.04(6a2) Solicitation of a person less than 16; 800.04(5b) attempted Lewd or Lascivious Molestation where the suspect is over 18 and the victim is under 12 and 827.071(4) Promotion of sexual performance by a child. This incident occurred in Okaloosa County Florida where your Affiant is a sworn law enforcement officer.
