[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 29 October 2015 at approximately 0200 I responded to a 911 call for a hurt individual who was located at Hughes St. and Opp Blvd. in Cinco Bayou.

Matthew Yahvu Peters did climb over the fence behind Patriot Arms located at 105 Hughes street entering a closed off area behind the closed business at approximately midnight; an area where a prudent person would not be found at this hour. Peters was found laying outside, next to the fence behind Patriot Arms.

I used my flashlight at Peters request so we could look inside the fenced area for his other shoe. Peters stated he was going to look for his shoe inside the fenced area. I looked inside the fence and found his flip flop wedged in between the fence boards from the inside of the fence.

When questioned why he entered this property he stated " I have no comment". Peters then started to walk away from me after being instructed to stop and answer my questions. I then grabbed Peters by the arm and told him to turn around and he tried to pull away from me again. Peters was taken to the ground and detained.

Peters was advised of his rights as per Miranda warnings using a prepared text.

Based on my observations, evidence and statements made by the defendant I have reason to believe and do believe defendant Peters has committed the act of Loitering and Prowling in violation of F.S.S. 856.021 and Resisting without violence in violation of F.S.S. 843.02. This incident occurred in Okaloosa County where I am a sworn law enforcement officer.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On November 2nd, 2015, the defendant, Matthew Y. Peters, did violate F.S.S. 837.06, False Official Statement, by filing a false written statement to mislead a public servant. The following probable cause was developed by reviewing the case file and the investigative report. Facts to support probable cause are as follows:

On October 31st, 2015, Defendant's brother submitted an officer complaint against an Okaloosa County Sheriff's Office Deputy Sheriff alleging the Deputy Sheriff falsified evidence against the Defendant and used excessive force arresting the Defendant causing physical injury to the Defendant. Per Florida State Statute, Chapter 112.533, an Administrative Investigation (Internal Affairs Investigation) was initiated and Inspector Robert W Norris, with the Office of Professional Standards, was assigned to investigate.

On November 2nd, 2015, the Defendant called Insp Norris and requested to file a written complaint against the Okaloosa County Sheriff's Office Deputy Sheriff. The Defendant completed an OCSO Commendation/Complaint Form alleging the Deputy Sheriff contacted him after he (the Defendant) called 911 for assistance. During the contact, the Defendant claimed the Deputy Sheriff restricted his freedom of movement and subsequently prevented him from leaving. The Defendant then claimed the Deputy Sheriff suddenly swept him off his feet and brought to the ground causing injury to his left arm and injuring his teeth. The Defendant was then subsequently arrested by the Deputy. Following completion of the OCSO Commendation/Complaint Form, the Defendant completed an oath, administered by Insp. Norris, claiming the

information was completely truthful. Prior to signing the statement, Insp Norris informed the Defendant it would be a crime to provide a false written statement.

Insp Norris then began the Administrative Investigation, which included the review of OCSO Intra department records, 911 communications recording, Deputy Sheriffs' sworn testimony, and review of OCSO body-worn camera videos refuted the Defendant's allegation. The subsequent investigation revealed the Defendant called 911 on/or about 00:00:20, October 29th, 2015, claiming he was hurt and on the ground. He claimed he was beside Public's Supermarket on Eglin Parkway, Fort Walton Beach, Florida. After an extensive search, emergency personnel were able to locate the Defendant adjacent to a closed business located at 105 Hughes Avenue, Fort Walton Beach. He was on the ground and had apparent injuries and kept touching and wiggling his front tooth. At one point, as revealed in a body-camera video, the Defendant was instructed to stop manipulating the injured tooth. The Defendant was extremely intoxicated and remained on scene waiting for a taxicab to pick him up and transport him to his residence. While waiting for the taxicab, an OCSO Deputy Sheriff developed evidence the Defendant actually entered a fenced in area of a closed business. The Deputy Sheriff attempted to detain the Defendant to further his investigation. As evidenced in the body-worn video, the Defendant attempted to pull away and was taken to the ground during arrest, but in very controlled smooth manner in a manicured grassy area of the business.

Based upon the above facts, I have reason to believe the Defendant did violate F.S.S. 837.06, False Official Statement. This offense occurred in the presence of law enforcement, in Okaloosa County, where I am a sworn law enforcement officer.
