**[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]**

On 2/22/2016, at approximately 2115 hours and while conducting an unrelated investigation at 6388 Old River Road, Baker, Florida, I observed a pickup truck traveling south on Old River Road at a speed much greater than the posted speed limit of 35 mph. As I attempted to catch up to this vehicle, I observed a red in color Ford pickup truck bearing Alabama tag 23AL519 stopped along the side of the roadway. As I slowed my speed to make contact with the driver, the vehicle accelerated rapidly spinning it's tires, traveling in a counterclockwise motion until the vehicle was facing north on the roadway. Upon contact with the driver, identified as defendant, Joshua Adam Greene, he eventually handed me a Florida Identification Card and stated that his license might be suspended for failure to pay child support. After confirming via FCIC his license status was suspended, he was placed into custody. Miranda Warnings was read to the defendant, and he advised he would speak to me without a lawyer present. During the Post Miranda interview, the defendant, advised the license plate which returned to a green in color Ford Taurus was placed on the Ford F150 by himself.

During an inventory of the vehicle, a loaded .45 caliber handgun, within a cloth holster was located between the center console and front driver's seat within reach of Greene. A Marlboro package of cigarettes were located in the overhead sunglasses compartment and within the cigarette package was a white plastic baggie which contained several white crystal like substances. Based upon my training and experience I believed this substance to be Methamphetamine. The defendant, advised he had no concealed weapon licence and denied ownership of the suspected drugs located in the cigarette package. This substance was later field tested and rendered a presumptive positive for methamphetamine weighing out of its package at 1 gram.

As per a NCIC/FCIC criminal history, the defendant is registered criminal. As per D.A.V.I.D. the defendant, was adjudicated guilty on 01/05/2010 (habitual traffic offender) and Adjudicated withheld-conviction on 05/23/2012 (habitual traffic offender). The defendant's most recent suspension was on 11/22/2015 for the non payment of Child Support.

Based on the aforementioned probable cause narrative, I have reason to believe the defendant was operating a motor vehicle without a valid license, was in possession of a firearm under by a convicted felon, possession of methamphetamine and attaching tag not signed.

These offenses occurred in Okaloosa County, Florida.
