Davis then used his personal vehicle a Ford F-150 and rammed the residence twice where Hawthorne was located causing injury and fear in Hawthorne that Davis was trying to kill him. Davis then entered the second victim's residence belonging to ///////////was on the porch when Davis pushed him down causing him to fall off the stairs and on the ground causing severe injuries. Davis lives on the same property in a travel trailer. This incident occurred at 402 E Pine St., Mary Esther, Florida.

Per sworn affidavit of complaint, William Hawthorne stated Davis was upset with him because Davis believed he stole some metal roofing tin from Hawthorne lives on the property in a small shed turned into a residence left of the main residence. Hawthorne stated he went back to his residence around 2100 hours, when he smelled kerosene outside. He then heard Davis say "come out nigger" with several other racial slurs. Davis then said "I want to kill you". Hawthorne stated he could still smell kerosene outside the residence. Hawthorne was at the door to the residence when he heard and saw Davis's truck driving toward his shed. Hawthorne advised Davis hit one side of the building, backed up and hit the building again. Hawthorne was hit by debris and the force knocked him into the bathroom. Hawthorne stated he was in fear of his life and feels that Davis was trying to hurt or kill him.
Per sworn written statement
Both Hawthorne and were transported to the hospital with injuries. It was learned that pelvis was broken in two places.
A witness from across the street, Nadian Springer, advised she was outside and heard a man yelling saying "come on Will, you good for nothing nigger, come on Will". She advised Davis got in his truck drove down the street, and then came back pulling in the driveway at 402E Pine Street. Springer then heard a series of crashes. Her and her husband, Robert, ran over to the house and saw Davis get out of his truck and walk into residence. She advised was laying on the concrete.
Several other witnesses also saw Davis drive his truck into the building where Hawthorne was located and seen Davis push off the top of the stairs.
Upon contact with Davis, he was holding a small knife in his right hand and telling me to shoot him. Davis was ordered to drop the knife but he refused to comply. Davis turned around to walk further into the residence with the knife by his side. Due to the fear of Davis barricading himself or taking a hostage, Davis was subdued by a Taser and taken into custody without further incident.
Post Miranda, Davis declined to speak about the incident.
Based on the investigation I have reason to believe that Ernest Emory Davis knowing and willingly violated Florida State Statue: 784.045.1a2-Aggravated battery person uses a deadly weapon (Hate Crime), Florida State Statue: 784.045.1a1- Aggravated Battery cause great bodily harm (DOMV), Florida State Statute: 843.02; Resisting an Officer Without Violence. This incident occurred in Okaloosa County where I am a sworn law enforcement officer.
