[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

Between July 2009 and January 2011 the defendant, Roy Anthony Pacheco did commit sexual battery (more than 15 times) and sexual molestation (more than 6 times) while the female victim was eight (8) and nine (9) years old, in Destin, Florida. Pacheco would put his penis into the victim's mouth, use his hands to touch the victim's breast, vagina and her butt both, under and over the victim's clothes. Pacheco had the victim touch and rub on his penis and Pacheco attempted to put his penis into the victim's vagina once. These incidents occurred in two locations in Okaloosa County, Florida.

On 04-10-14 during the Forensic Interview the victim advised when she was 8 years old she lived in the Destin, Florida. The victim advised Pacheco would just pull his pants down and show "it" (his penis) to her and would tell her "to suck it" and Pacheco would have her rub on "it" (his penis). The victim advised these incidents would occur in both her bedroom and in Pacheco's bedroom. Pacheco would have the victim put her mouth on his penis and she advised "white stuff" would come out of Pacheco's penis, but he would tell her "to stop or he is about to" and the "white stuff" would go on him. This occurred between five to ten times in the . The victim also advised Pacheco would open the bathroom door when she was getting in or out of the shower without knocking and catch her without any clothes on.

The victim stated when she was 9 years old the victim's mother), Destin, Florida. Pacheco started kissing her and he used his hands to touch her on the breasts, vagina and butt, both over and under her clothes. The victim stated Pacheco would have her touch his penis with her hands and her mouth between 10 to 20 times. The victim advised at this address Pacheco tried to "break it" which was attempting to have sexual intercourse but she kept him from doing it.

The victim stated Pacheco has a tattoo of "Superman" on his left side which would not be seen unless his clothes were off.

Pacheco told the victim not to tell her mother anything that goes on, "this is just between you and me". When Pacheco would tell the victim to "suck it" she would do it because Pacheco told her if she did not do it there would be consequences.

Pacheco had previous knowledge of the victim being a victim of sexual assault in the past by another adult male and he mentioned abused children would either "go crazy for sex" or "never being able to accept being loved".

The victim's mother verified [REDACTED] in 2009 when the victim was 8 years old living in [REDACTED] In June 2010 they moved to [REDACTED] Destin, Florida and stayed there until January 2011. [REDACTED] Pacheco worked at the Bass Pro Shop and New Balance at the Outlets during the time [REDACTED]

Based on the above information and investigation I believe the defendant, Roy Anthony Pacheco, did violate F.S.S. 794.011(8)(c) Sexual Battery (more than 15 times) and F.S.S. 800.04(5)(b) Lewd and Lascivious Molestation (more than 6 times) with the female victim who was 8 and 9 years old by putting his penis in the victim's mouth, using his hands to touch the victim's breast, vagina and her butt and having her touch and rub on his penis. These incidents occurred in Okaloosa County, State of Florida.
