[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Saturday March 19, 2016 approximately 1304 hrs, I made contact with Brittany Nicholson at 665 Navy Street. Nicholson is a 21 year old single female who is 8 weeks pregnant. Nicholson states Tyree Dante Jones is the father of the baby and he is aware that she is pregnant.

Brittany Nicholson has made a written and verbal statement that on the above date, approximately 1245 hrs, Jones showed up at 665 Navy Street and waited on the front porch until Nicholson came outside.

Jones pulled Nicholson by the arm into the front yard and struck Nicholson in the stomach many times. Jones made the statement he wanted to kill her baby.

Tonya Cobb also made a written and verbal statement that she was inside her residence at 665 Navy Street when she heard a commotion outside. Cobb went outside and saw Jones, whom she know by sight, strike Nicholson at least four times in the stomach. Cobb states she heard Jones say he wanted to kill her baby. Jones also threatened to shoot up her house and her mother's house.

Jones fled the scene prior to law enforcement arrival.

Based on the statements from the victim and of the witness, I have reason to believe and I do believe that Tyree Dante Jones has violated the following Florida State Statutes, 784. 045 (1b), Aggravated battery (victim known to be pregnant)
