[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 4/3/16 the defendant, Yoni Chacon-Guerra, did willfully violate F.S.S. 784.045.1a2 Aggravated battery with a deadly weapon and F.S.S. 843.02 obstructing while at 931 Vincent Ln FWB,FL.

On the above date the victim, Juan Arevalo, went to the defendant's residence to speak with him about damage to the defendant's vehicle. The defendant was angry and blamed the damage on the victim. As the victim approached the front door, the defendant came out side holding a machete. The defendant began backing away, but the defendant hit him several times in the abdomen. While backing up, the victim fell near the front porch. The defendant continued to strike the victim with the machete while he was on the ground, hitting him several times.

I did observe multiple lacerations on the victim's chest and abdomen. There were also multiple defensive wounds on both the victims arms and hands. Specifically one defensive wound on the victim's right hand between the thumb and first finger where he attempted to block the machete from hitting him. This caused a sever laceration which required surgery.

Post Miranda, the defendant admitted to hitting the victim with the machete, saying the victim hit him in the head with a cell phone and he was defending himself. I did not observe any injuries, swelling or redness on the defendant's head. No cell phone was located. The defendant's details were inconsistent and changed until he became uncooperative.

Once at the booking facility, booking deputies attempted to identify the defendant, but he refused to give his name or date of birth. The defendant's name was given by family members.

Based on my investigation I have reason to believe and do believe the defendant, Yoni Chacon-Guerra, did willfully violate F.S.S. 784.045.1a2 Aggravated battery with a deadly weapon and F.S.S. 843.02 obstructing. These offenses occurred in Okaloosa County, FL.
