[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Between May 7, 2016 and May 8, 2016, the defendant, Kenneth Cadel Ellis Jr. violated F.S.S. 810.02 (4)(b); Burglary to a conveyance (6 counts), F.S.S. 812.014 (2)(c)(1); Grand theft over \$300.00, less than \$5000.00 and F.S.S. 806.13 (1)(b)(3); Criminal mischief over \$1000.00. Facts and circumstances to support this probable cause are as follows:

On May 8, 2016, Deputy Cantwell responded to the Destin United Methodist Church, 200 Beach Drive, Destin, Florida. He located several trailers, a box truck and a small bus. The vehicles and trailers were parked in the rear parking lot of the church. He checked the trailers and it was obvious the locks had been pried open. The following is a list of vehicles that were burglarized/damaged:

2015 white Ford E150 van, Florida tag X1707A, passenger side broken window and various scratches; \$800.00.

2004 white Isuzu cargo truck, Florida tag X4627C, drivers side broken window; \$500.00.

2004 Ford Starcraft bus, Florida tag X8147A, right panel door glass broken; \$1200.00 damage.

Carry on Trailer (Church), Florida tag 914RXN, broken hasp; \$10.00

Elite Trailer, Florida tag 5531BE, broken hasp; \$20.00

Elite Trailer, Florida tag 537SAJ, cut lock; \$5.00

The estimated value of damage to the vehicles/trailers is \$2,535.00.

Property stolen from the vehicles consisted of 250 t-shirts valued at \$1,562.50 and cash from the cash bag at \$60.00. The estimated value of the theft is \$1,622.50.

Deputy Kruger responded to process the crime scene. While searching the area boxes were located under the box truck which once contained neon yellow shirts belonging to Destin United Methodist Church. Under the boxes was a long piece of rebar which is believed to have been used to pry open the locks. While inspecting and photographing the rebar paint transfer was observed which matched the door paint of the storage unit 815 at A Solution Storage (16-5548).

Sgt Watkins canvassed the area at the abandoned Destin 10 movie theater, which is in close proximity. Sgt Watkins located more boxes which also belonged to the church that contained the same neon yellow shirts. The boxes were located underneath a moving blanket which was also located in one of the vehicles. Near the blanket and bags was a money bag from the vehicles. There was one shirt located with the boxes located behind the movie theater.

While in the area of the movie theater Deputy Cantwell located a fresh shoe tread impression which matched another tread impression found both at the scene of the church vehicle burglaries and the scene of the storage unit. Morgan provided a sworn written statement listing the theft of 250 shirts valued at \$1,562.50 and cash from the cash bag at \$60. The total value of the theft is \$1,622.50.

On May 11, 2016, Thomas Denney provided your affiant with a list of more stolen property from the church vehicles, which consisted of various Boy Scout camping equipment. The estimated total value of this property is \$1,070.00.

On May 11, 2016, the defendant was arrested for criminal mischief when he shattered a glass door at the abandoned Destin 10 movie theater. The tread on his shoes matched shoe tread impressions at this scene and at A Solution Storage. Post Miranda, the defendant initially denied breaking the theater window and committing burglaries. During a canvas of the area your affiant located a blue suit case on the north side of the theater. The defendant later admitted to stealing the suit case from Goodwill and there was stolen property inside it. He also admitted to the burglaries and theft to the vehicles at Destin United Methodist Church. The defendant also stated there was more stolen property behind the Krispy Kreme donut business.

Deputy Walters and his trainee, Deputy Rudd inventoried the contents of the suit case and found t-shirts belonging to Destin United Methodist Church, the security cameras belonging to Goodwill (16-5735) and a Garmin GPS unit which is believed to have been stolen from a vehicle at Wingate Hotel (16-5677).

Your affiant located the property behind Krispy Kreme, which consisted of two more Destin United Methodist t-shirts, property belonging to the boy scouts and other miscellaneous property. Your affiant then located other miscellaneous stolen property from the church in the parking lot of the abandoned Popeye's Chicken restaurant, 753 Harbor Blvd and the dumpsters at Goodwill, which is located next door to Popeye's.

Based on the above information, your affiant believes the defendant, Kenneth Cadel Ellis Jr. committed the burglaries, grand theft and criminal mischief which occurred in Okaloosa County, Florida.

During a post Miranda interview with DEFENDANT, he admitted to possessing a bag full of stolen items. In the bag were two surveillance cameras that appeared to be pulled off of a base. Attached to the cameras were the cords. DEFENDANT said he took the cameras off of the building at the Goodwill, 747 Harbor Boulevard, Destin, to keep from being seen while he took items from their drop off location.

On 05/12/16 I responded to the Goodwill and made contact with the manager, Julie Jones. Jones provided a sworn affidavit of complaint advising she only noticed the cameras due to law enforcement arrival. She contacted the loss prevention office and confirmed there were two surveillance cameras attached to the outside of the building in the curtilage. Loss prevention pulled up the camera system remotely and confirmed both cameras were inactive. The value of the cameras are \$130.00, totalling the value at \$260.00.
