[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Thursday May 19, 2016 approximately 1816 hrs, I observed suspicious activity while a 2016 Toyota sedan was stopped at the Tom Thumb convenience store, 1096 N Beal Parkway, Fort Walton Beach, Florida.

I attempted to make a consensual encounter with the occupants of the 2016 Toyota sedan, LA N432637, after it pulled into the Sonny's Bar B Q restaurant at 925 N Beal Parkway. As I approached the vehicle it sped away at a high rate of speed. It crossed Beal Parkway at Patrick Drive, during rush hour traffic, with a wanton disregard for public safety, without stopping at the stop sign. The vehicle continued to flee as Deputy Schlager attempted to stop it using emergency lights and siren on Cloverdale Boulevard in speeds of excess of 75 MpH.

The vehicle crashed at 305 Cloverdale Blvd, and the driver, Keenan Jamal Boggan fled into the backyard of 305 Cloverdale. The rear seat passenger, Steven Keith Cordova fled the car and was found hiding under a bush near the side of the residence.

The vehicle, a Heritz rental car, had two digital scales, 6 cell phones, and \$ 16 dollars in the center console, and under the radio. Both scales contained a white residue. A field test was conducted which resulted in a presumptive positive for cocaine. The driver was arrested for possessing a controlled substance with intent to sell.

Steven Cordova is out of jail on bond for a violation of probation warrant.
