[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On May 24, 2016 at approximately 0720 hours the defendant, Gregory Edward Hertzing, was involved in a traffic crash on U.S. Highway 98 east of Restaurant Row, Destin, Florida. The defendant was operating his red Nissan truck bearing Florida tag 5904UH eastbound on U.S. Highway 98 and struck a bicyclist traveling in the same direction. The bicyclist/victim was thrown into the air and then collided with the pavement in the turn lane near Silver Shells Beach Resort. The defendant continued traveling approximately one-quarter mile and stopped to assess the damage to his vehicle by exiting his vehicle and physically looking at the damage to the passenger side which was witnessed by another motorist. The victim received multiple lacerations to his face, forehead, and eve area as well as multiple abrasions to his arms and legs and a large laceration to his abdomen. where he was located and even being involved in the collision.

The witness provided a sworn written statement advising he observed a red Nissan truck bearing Florida tag 5904UH just east of the injured bicyclist and watched as a white male exited the vehicle and assess the damage. He stated the male was an older white male wearing khaki shorts and a neutral colored shirt. He then witnessed him get back in his vehicle and depart the scene eastbound on U.S. Highway 98.

The defendant's vehicle was located several hours later at his residence at 543 Sibert Avenue, Destin, Florida. The defendant, who was wearing khaki shorts and a grey shirt, was read his Miranda Warning from a prepared text and stated he understood his rights and would answer questions. The defendant denied being involved in a collision on today's date. When questioned about the damage to his vehicle, to include the missing passenger side mirror, he stated he struck a light pole at Wal-Mart a few days prior. The defendant later admitted to being involved in a collision in the area of U.S.

Highway 98 and Restaurant Row but was unsure what he struck, therefore, he did not call law enforcement. The defendant later stated the bicyclist was in his lane of travel but was adamant he was unsure what he struck.

With the defendant's permission I held up the mirror and two pieces of the headlight assembly from the crash scene to the defendant's vehicle which matched identically. One piece of the headlight assembly had the victims blood on

Based on my investigation, which consisted of interviews with the victim, witness, and defendant, and gathering of physical evidence, I have reason to believe the defendant, Gregory Edward Hertzing, violated F.S.S. 316.027(1a)-Leaving the scene of a collision involving serious injury without rendering aid. This incident occurred in Okaloosa County, Florida where I am a full time sworn Law Enforcement Officer.
