[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On November 06, 2001, June 6, 2004, January 5, 2006 and March 15, 2016, the defendant, Jonathan Louis Floyd was convicted of driving while license was suspended. Floyd's drivers' license showed suspended for failing to pay CT Obligations and was classified as a habitual offender on March 6, 2006.

On June 11, 2016, Floyd did commit the offense of fleeing and eluding, driving while license was suspended

with 3 or subsequent offenses, tampering/destruction of evidence and being in possession of counterfeit money located near/at MM 50 on interstate I-10, Holt, Florida.

On the aforementioned date, I was parked on interstate I-10, facing in a westerly direction and observed a maroon in color vehicle traveling west bound and estimated the vehicle's speed at 87 MPH. I utilized my assigned radar and the vehicles actual speed was 84 MPH in a 70 MPH zone.

I pulled out onto I-10, activated my lights and sirens and attempted to conduct a traffic stop on the 2001 Pontiac 4-door bearing Florida tag DRTW25 located at I-10 at at/near mile marker 50, Holt, Florida.

Floyd slowed down, pulled onto the south side of I-10 shoulder and continued moving east bound while making eye contact with me. He then moved back into the roadway and continued east, towards Crestview, Florida. Floyd continued to look at me in his side and rearview mirror. Floyd continued to travel between 70-75 MPH until we reached MM 52 and he picked up his speeds around 80-85 MPH.

As Floyd approached Antioch Road Bridge he continued east with his speed between 85-90 MPH. At this point, Floyd threw out a white item out of the driver's front window, which landed on the highway. We continued east and as we passed the exit ramp for Crestview, just east of Jerico Bridge, Floyd threw another white item that contained several pieces of an unknown item out the driver's side window. Floyd picked up his speed and traveled between 95-100 MPH. This allowed Floyd to distance himself between the other deputies and myself. Floyd slowed down a couple times in order to move around the other vehicles on the roadway but continued to pick up his speed as he traveled into Walton County jurisdiction. Once Floyd approached exit 285 (near MM 70) he threw a black object out of the driver's front window, which landed on the roadway.

When Floyd reached MM 80, Walton County Sheriff's Office assisted with the pursuit. As we approached exit 331, Floyd took a sharp right onto the exit ramp, continued towards the intersection, left the roadway and went onto the shoulder, crossed 331 intersection without stopping and hydroplaned into the ditch across the street. Floyd exited the vehicle and fled on foot. Floyd was appended seconds later without any further incident.

Deputies actively pursued Floyd for approximately 35-40 miles on I-10 before he was taken into custody.

The area was searched where Floyd threw the items from his vehicle and several pieces of counterfeit money was located on the interstate where the items were disposed of.

A check through NCIC/FCIC revealed Floyd had a suspended driver's license and was classified as a habitual traffic offender.

Post Miranda, Floyd admitted he did not have a valid driver's license and only threw out his cellular phone and a napkin.

Based on my investigation, which consisted of an interview with the defendant, my personal observation and collection of evidence I have reason to believe and do believe that the defendant, Jonathan Louis Floyd violated the provisions of F.S.S. 316.1935(3) fleeing and eluding, 322.34(2)(c) driving while license is suspended 3rd or subsequent offense, F.S.S 918.13 tampering/destroying evidence to wit; by throwing counterfeit money out the driver's side window and F.S.S 831.11 Fraud to wit; by being in possession of counterfeit money. This incident occurred in Okaloosa County where I am a sworn law enforcement officer.
