[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 06/14/16, members of the Okaloosa County Sheriff's Office Narcotics Unit executed a narcotics search warrant following multiple narcotics tips regarding narcotic trafficking occurring at 210 Pelham Road, Apartment 107A, Ft. Walton Beach, FL. The search warrant was signed by Judge T. Ketchel.

During the execution of the search warrant, the defendant Elizabeth Womack was detained and advised of her

Miranda Warning. Investigators located a shoe box on top of Womack's bed. The shoe box contained 35 small plastic jeweler bags, each filled with approximately 1/2 of a gram of cocaine. The shoe box also contained two digital scales with cocaine residue. Womack admitted that the cocaine belonged to her and stated that she "liked to get high". The cocaine from the jeweler bags and the cocaine residue from the digital scales field tested positive for the presence of cocaine.

Investigators also located an Aqua Net Hair Spray bottle with a false bottom laying on Womack's bed. The can contained an additional 18 grams of powder cocaine and approximately 2 grams of fentanyl. Womack admitted that her finger prints would be on the bottle and that she used heroin. The powder cocaine located in the Aqua Net Hair Spray bottle field tested positive for cocaine and the fentanyl from the bottle field tested positive for fentanyl.

Investigators seized less than a gram of a crystalline substance in a brown cup holder on Womack's nightstand. The crystalline substance field tested positive for MDPV.

This is in violation of F.S.S. 893.135 Trafficking in cocaine approximately 35 grams; F.S.S. 893.13 (6a) Possession of a controlled substance (2CTS); and F.S.S. 893.147 Possession of narcotics paraphernalia. These violations occurred in Okaloosa County where I am a sworn law enforcement officer.
