[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On June 08, 2016, members of the Okaloosa County Sheriff's Office Narcotics unit executed a narcotics search warrant at 920 Denton Boulevard, Apartment #705, Fort Walton Beach, Okaloosa County, Florida.

During the execution of the search warrant, the DEFENDANT, Dylan RUSNAK, was located on a bed in a bedroom located on the west side of the residence. This room was identified as the DEFENDANT's bedroom by the DEFENDANT's mother and the DEFENDANT's admission.

Inside of this bedroom, Investigators located a book bag that contained six (6) sandwich bags that contained approximately twenty-eight grams of marijuana each, a digital scale, and packaging materials for the sell and/or distribution of controlled substances. The marijuana and digital scale field tested presumptive positive for the presence of Tetrahydrocannabinol (THC).

Post Miranda, the DEFENDANT denied selling marijuana and was uncooperative with questioning.

There is probable cause to believe and your AFFIANT does believe, Dylan RUSNAK knowingly violated Florida State
