[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 7/17/16, at approximately 1022 hrs, I was traveling northbound in the far right hand lane on Eglin Pkwy while approaching the Cinco Bayou bridge when I observed a silver 2004 Volvo bearing FL tag of 03531A driving very slow. As I approached the Highway Av intersection I slowed down to 25 miles per hour in a 40 mile per hour zone. At that time I estimated the Volvo was traveling at a rate of 20 miles per hour or less, which is unusual on Eglin Pkwy. I stopped my marked patrol vehicle on the right side of the road and let the Volvo pass me in order to get behind it. After getting behind the Volvo, I followed the Volvo while driving northbound on Eglin Pkwy. I approached the Racetrack Rd intersection where I observed the Volvo was unable to maintain its lane. I initiated a traffic stop with my emergency lights near the intersection of Eglin Pkwy and Racetrack Rd.

The driver of the Volvo, later identified as 13 year old Tamia Ida Gray, began to speed up while traveling

northbound on Eglin Pkwy. There was light traffic and light rain at the time. I continued behind the vehicle and now activated my siren. Gray began to speed up and changed lanes to pass upcoming traffic. As I approached Gardner Dr in Shalimar I was traveling at a rate of 77 miles per hour and Gray's vehicle was pulling away. I terminated the pursuit due to Gray's excessive speed, upcoming traffic, and wet road conditions.

Gray was still pulling away from my patrol car and appeared to still be speeding up. Gray's vehicle then struck a vehicle near the intersection of Eglin Pkwy and 6th Av in Shalimar. The vehicle that was struck was disabled and Gray's vehicle traveled across oncoming traffic from the southbound traffic on Eglin Pkwy. Gray drove the vehicle over a curb and down into a ditch in front of Waterworx Carwash where the vehicle was stopped and disabled.

Gray exited the driver side, front left door, and her passenger exited through the same door. Gray and the co-defendant both ran westbound behind the car wash. Myself and other Deputies went to the backside of the car wash where both Gray and the co-defendant then ran eastbound, crossing Eglin Pkwy, and then into the McDonald's parking lot. During this foot pursuit multiple Deputies pursued while wearing an Okaloosa County Sheriff's Office uniform and yelling for them to stop. Both Gray and the co-defendant both finally stopped, got on the ground, and handcuffed.

Gray admitted to driving the vehicle at rate of 90 miles per hour, hitting the other vehicle, and running from law enforcement. Gray also was told the car she struck had a infant in the car. Gray stated she did not care about the baby in the car.

The co-defendant admitted that Gray was driving, that Gray struck the other vehicle, and that Gray hit 90 miles per hour.

Based on my investigation, which included statements made by both the defendant and co-defendant, and my personal observations; I believe Tamia Gray committed the act of Fleeing and Eluding driving at a high rate of speed and a wanton disregard for other's safety and Resisting an Officer without Violence by fleeing on foot, which is in violation of Florida State Statutes 316.1935.3 and 843.02. This incident occurred in Okaloosa County, Florida.

[REDACTED] admitted that she told the co-defendant to speed up in order to get away from us during the traffic stop and pursuit. [REDACTED] also stated the only reason she did stop running while she was on foot was because she thought she was going to get "tazed."

Based on my investigation, which included statements made by both the defendant and co-defendant, and my personal observations; I believe [REDACTED] committed Resisting an Officer without Violence by fleeing on foot, which is in violation of Florida State Statute 843.02. This incident occurred in Okaloosa County, Florida.
