[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 07/13/2016, the defendant, Daaron Chance Taylor, was observed operating a stolen green 2016 Toyota Highlander bearing FL tag 598PMD traveling westbound on 2nd Avenue near the intersection of Still Mill Creek Road, Laurel Hill, Florida. After activating my emergency light and siren in an attempt to stop the vehicle, Taylor accelerated in speed (approximately 80mph), at one point in the wrong lane, nearly struck two marked OCSO patrol vehicles, and he blatantly ran two stop signs without slowing down. Total, Taylor traveled approximately .85 miles before crashing the stolen vehicle at the intersection of 2nd Avenue and 8th Street, Laurel Hill, Florida.

Post Miranda, Taylor admitted to stealing the vehicle while burglarizing vehicle on 07/12/2016, and also admitted to fleeing law enforcement upon sight.

A search of the vehicle revealed a set of black gloves and a silver flashlight which Taylor admitted to utilizing while breaking into and stealing vehicles.
