[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 08/15/2016, I responded to 77th Special Forces Way on Eglin Air Force Base, Florida in reference to an armed disturbance which had just occurred.

Upon arrival, I learned that Ariel Mclaughlin and the defendant, Joshua Foster, were the involved parties. They have been in a dating relationship for approximately six months and living together for five months. Mclaughlin reported that Foster has recently displayed physically abusive behavior, therefore she started moving her belongings out of their residence today (08/04/2016). After Mclaughlin agreed to accept a ride home from the defendant earlier in the evening, he drove her out into the wooded area of Eglin range near Range Road 213.

Once at the range, the defendant required Mclaughlin ride in the bed of the truck. Eventually, the defendant stopped, exited the truck, and "antagonized" Mclaughlin, telling her to ask nicely to ride in the cab. After she asked several various ways to ride in the cab, the defendant denied her and fired a round from his Glock 23 pistol. Mclaughlin reported her ears started ringing and she was in fear for her life. He fired another shot and asked her again, "Now, how do you ask to get in the truck?" Mclaughlin jumped from the truck bed and ran into the woods for safety.

The defendant did admit he fired several rounds from his firearm while in the vicinity of Mclaughlin.

Based on the totality of circumstances, I have reason to believe and do believe the defendant, Joshua Foster, did willfully and intentionally violate domestic related F.S.S. 784.021.(1)a - Aggravated Assault With a Deadly Weapon Without Intent to Kill. This offense did occur in Okaloosa County, Florida where I am a sworn law enforcement officer.
