[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On Saturday, 8/13/2016, Defendant Antonio Vann and four other inmate defendants, aggressively attacked Okaloosa Youth Development Center employee, Quaddarivs Tramone Colvin, for the purpose of taking his cell phone. Colvin was repeatedly attacked by the defendant and his accomplices by striking him with a closed fist, biting, choking, kicking and kneeling him about the body. The defendant was able to remove Colvin's cell phone from his pocket during the attack temperately depriving him of his property. The cell phone was later recovered by other staff members.

As per sworn statement of Colvin, he was making a phone call in the presence of the defendant when Vann demanded his phone. When Colvin refused to allow the defendant use of the phone, he was subsequently attacked by the defendant. The defendant struck Colvin with a closed fist and began choking him while other inmates began to join in the attack.

Colvin sustained injuries as a result of being battered. These injuries included, but not limited to, a busted lip, a cut and swelling below his left eye, and a bite mark which broke the skin between his shoulder blades. In addition to inciting others to attack Colvin, Vann choked Colvin during the attack.

This incident was captured by surveillance video obtained from the facility, and supported by witness statements and physical injuries of Calvin.

Based on the above I have reason to believe the Defendant Antonio Vann commit the offenses of Aggravated Battery of a detention staff member, FSS 784.075 and Grand Theft, FSS 812.014(2c1)

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On Saturday, 8/13/2016, Defendant Jamarcus Howard and four other inmate defendants, aggressively and brutally attacked Okaloosa Youth Development Center employee, Quaddarivs Tramone Colvin, for the purpose of taking his cell phone. Colvin was repeatedly attacked by the defendant and his accomplices by striking him with a closed fist, biting, choking, kicking and kneeling him about the body and head. During this attack the victim/staff member had his facility keys forcefully removed from his person.

As per sworn statement of Colvin, he was making a phone call in the presence of the defendant when Howard demanded his phone. When Colvin refused to allow the defendant use of the phone, he was subsequently attacked by the defendant. The defendant struck Colvin with a closed fist and began choking him while other inmates began to join in the attack. In the course of the attack, Howard removed Colvin's cell phone from his person. The phone is described as an Apple iPhone 6s+ and valued at \$800.00.

Colvin sustained injuries as a result of being battered. These injuries included, but not limited to, a busted lip, a cut and swelling below his left eye, and a bite mark which broke the skin between his shoulder blades. In addition to inciting

others to attack Colvin, Howard choked Colvin during the attack.

This incident was captured by surveillance video obtained from the facility, and supported by witness statements and physical injuries of Colvin.

Based on the above I have reason to believe the Defendant Jamarcus Howard commit the offenses of Aggravated Battery of a Detention Staff Member, FSS 784.075. Howard further violated FSS 812.131(2b) in that he did forcefully remove Colvin's phone with intent to deprive him of his property.

Colvin sustained injuries as a result of being battered that included, but not limited to, a busted lip and a bite mark which broke the skin between his shoulder blades.

This incident was captured by surveillance video obtained from the facility, and supported by witness statements and physical injuries of Colvin.

Based on injuries and video evidence I have reason to believe the defendant Jarrod Mingo committed the offense of Aggravated Battery of a detention staff member in violation of FSS 784.075.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On Saturday, 8/13/2016, Defendant Cornell Hayes and four other inmate defendants, aggressively and brutally attacked Okaloosa Youth Development Center employee, Quaddarivs Tramone Colvin, for the purpose of taking his cell phone. Colvin was repeatedly attacked by the defendant and his accomplices by striking him with a closed fist, biting, choking, kicking and kneeling him about the body and head. During this attack the victim/staff member had his facility keys forcefully removed from his person.

As per sworn statement of Colvin, he was making a phone call in the presence of the defendant when Hayes demanded his phone. When Colvin refused to allow the defendant use of the phone, he was subsequently attacked by the defendant. The defendant struck Colvin with a closed fist and began choking him while other inmates began to join in the attack. In the course of the attack, Howard removed Colvin's cell phone from his person. The phone is described as an Apple iPhone 6s+ and valued at \$800.00.

Colvin sustained injuries as a result of being battered. These injuries included, but not limited to, a busted lip, a cut and swelling below his left eye, and a bite mark which broke the skin between his shoulder blades. In addition to inciting others to attack Calvin, Hayes choked Calvin during the attack.
