[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On August 14, 2016, the defendant Christian Morgain (DOB 5/10/93) did violate F.S.S. 784.041(2) A Domestic Battery by Strangulation and F.S.S. 784.045 (1)B Aggravated Battery on Pregnant Victim. Information to support this probable cause is as follows:

On the above date, I responded to Panini Pete's located at 1071 U.S. Hwy 98 Destin, Okaloosa County FL 32541 in reference to a battery Upon arrival I made contact with the Victim, Marina Milligan who provided the following via sworn written statement: While at Panini Pete's the victim walked into the bathroom with The defendant followed the victim into the bathroom and began to throw her up against the wall. Once on the floor the defendant picked the victim up by her hair and began to strangle her. The victim advised that the defendant had her pinned up against the wall with one hand around her throat and one hand over her mouth and nose. While the defendant was strangling the victim she stated she felt like she was about to lose consciousness. The victim was visibly pregnant and advised that she is pregnant with the defendant's child. The victim stated the defendant is aware of the pregnancy and that they live together as a family. The defendant fled the scene after an employee forced the door open and ordered the defendant to stop. The victim advised this isn't the first time the defendant has battered her.
