[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On August 16, 2016, at approximately 1000 hours, Nicholas John Iolo traveled from Fort Walton Beach, Okaloosa County, Florida to a predetermined location in Okaloosa County Florida for the purpose of engaging in sexual activity with a person he believed to be a 14 year old minor. During conversations, which occurred from June 26 through August 16, 2016, with the undercover officer who was posing as a 14 year old , Iolo did solicit to engage in illegal sexual activities

with a minor child seven (7) times and sent three (3) images of his penis to the person he thought was a minor. A predetermined location was given to Iolo via electronic communications. At approximately 1015 hours, Iolo arrived in the parking lot adjacent to the predetermined location and attempted to perform counter surveillance on the location. Nicholas John Iolo was then taken into custody.

Post Miranda, Iolo admitted to sending emails and text messages to the undercover officer. Iolo also admitted to sending sexual text messages and pictures of his penis to the undercover officer posing as the 14 year old minor.

During an inventory of the vehicle, Okaloosa County Sheriff Deputies observed Iolo had three cellular devices in the vehicle. All of these cellular telephones were seized as evidence. Iolo also had condoms and lubricant in the vehicle which were photographed.

Based on the above stated facts, I have reason to believe and do believe the defendant, Nicholas John Iolo violated F.S.S. 847.0135(3a), F.S.S. 847.0135(4a); F.S.S. 847.0135 (5b) and F.S.S. 934.215. These incidents did occur in Okaloosa County, State of Florida where I am a sworn Investigator with the Okaloosa County Sheriff's Office.
