[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Sunday, September 11, 2016, I responded to an undetermined disturbance at County Road 393, Laurel Hill, Okaloosa County, FL. As I was responding, the 911 caller reported hearing a male yelling "Michael is trying to kill me".

In the course of my investigation I discovered Michael Reeves attempted to have forced sexual intercourse with on Saturday, September 10 and Sunday, September 11, 2016. In the September 10 incident, Michael

Reeves approached [redacted] with an expressed intent to have sexual intercourse with him. When [redacted] resisted, Michael armed himself with a 6 inch bladed file knife. During the altercation, Michael Reeves stabbed [redacted] in the lower abdomen causing a shallow incision. [redacted] managed to escape the residence and flee to safety. [redacted] did not report this initial incident to law enforcement after it occurred. This incident took place at the [redacted] County Road 393 in Laurel Hill.

In the early morning hours of Sunday, September 11, 2016, Michael Reeves again approached [redacted] with an expressed intent to have forced sexual intercourse with him. [redacted] defended himself from the assault and again fled the residence. [redacted] escaped to [redacted] neighbor and obtained refuge. Witnesses observed Michael Reeves attempting to force his way into the residence at 7885 County Road 393 in an effort to continue the battery against [redacted]. This is the residence of Barbara Reeves.

I observed injuries consistent with a stab wound on [redacted] lower abdomen. I also noted bruising and lacerations on [redacted] consistent with battery. Independent witness statements corroborated [redacted] account of the incident on September 11, 2016. In my interview with [redacted] he stated he believed [redacted] was attempting to forcibly rape him and feared for his life. I recovered a file knife with a 6 inch blade from inside the Reeves home. [redacted] identified the knife as the same one used by Michael Reeves to threaten harm and stab him in the abdomen during the attempted rape on September 10.

While in the back seat of my patrol vehicle, and handcuffed, Michael Reeves lowered the window and attempted to escape by climbing out of the rear window. I re-secured Michael Reeves in the back seat and increased security on him until I transported him to the Okaloosa County Jail.

Based on a totality of the circumstances, I have probable cause to believe Michael Reeves violated Florida State Statute 794.011(3) in that he willfully, intentionally, and unlawfully attempted to rape [redacted] while armed with a knife. I have probable cause to believe and do believe Michael Reeves violated Florida State Statute 784.045(1A2) in that he did willfully, intentionally, and unlawfully stab [redacted] in the lower abdomen with a fixed bladed knife causing bodily injury. I further have probable cause to believe and do believe Michael Reeves violated Florida State Statute 810.02(3c) in that he did willfully, intentionally, and unlawfully attempted to enter the residence of Barbara Reeves with the intent to commit battery against [redacted]. I have probable cause to believe and do believe Michael Reeves violated Florida State Statute 944.4 in that he did willfully, intentionally, and unlawfully attempt to escape the custody of the Okaloosa County Sheriff's Office by climbing through the window of a patrol vehicle after having been arrested for felony offenses. These offenses occurred in Okaloosa County where I am a sworn law enforcement officer.
