[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On September 15, 2016, the defendant, ANDREW SMEDLEY JR., and the co-defendant, Jaurice Rycal Williams, did commit the offense of grand theft auto, resisting without violence, burglary to a structure and loitering and prowling located near the intersection of Michael Avenue and Bob Sikes Boulevard, Fort Walton Beach, Florida.

On September 13, 2016, the victim, Christopher Boudoin reported his 2006 Nissan Xterra bearing Texas tag BLF0879 stolen from his residence located at 123 Marimba Street, Mary Esther, Florida.

On September 15, 2016, the co-defendant was driving/operating the reported/stolen Nissan and turned in front of a 2003 gold Jaguar 4-door bearing Florida tag 343NFS that was traveling east, which caused a traffic crash. SMEDLEY was the front passenger.

SMEDLEY and the co-defendant got out of the vehicle and fled on foot, heading south on Michael Avenue, towards Bob Sikes Boulevard, Fort Walton Beach; which was observed by several witnesses in the area.

I observed SMEDLEY and the co-defendant running near the intersection of Michael Avenue and Bob Sikes Boulevard and ordered both subjects to stop. SMEDLEY and the co-defendant continued to run and jumped over a chain-link fence which led into the front yard of 709 Bob Sikes Boulevard, Fort Walton Beach. I again ordered SMEDLEY and the co-defendant to stop and they continued to run and jumped over several surrounding resident's chain-link fences in order to get away from law enforcement.

A perimeter was setup and the area was checked.

The co-defendant's red/white/black Nike tennis shoes were located near the chain-link fence of one of the adjacent yards located at 410 Gerold Street, Fort Walton Beach. When the co-defendant was apprehended by deputies inside the residence he had no shoes on and was arrested without further incident.

A witness who resides at 405 Gerold Street observed SMEDLEY on the front porch hiding from law enforcement and informed deputies on scene. SMEDLEY was apprehended shortly thereafter without further incident.

Post Miranda, SMEDLEY denied operating/diving the vehicle at the time of the crash and admitted he was inside the vehicle with the co-defendant. SMEDLEY and the co-defendant admitted they heard deputies giving them a lawful order to stop. The co-defendant stated he provided an individual known as "Jimmy" with \$40.00 worth of crack for the vehicle.

During the interview with SMEDLEY and the co-defendant they both failed to dispel deputies concerns about their actions.

Based on my investigation, which consisted of interviews with the witness, defendant, gathering of physical evidence and my personal observations, I have reason to believe that the defendant, ANDREW SMEDLEY JR did violate the provisions of F.S.S.812.014 (2)(c)6 grand theft of a motor vehicle to wit; by taking the victim's vehicle without permission, F.S.S 843.02 resisting without violence to wit; by knowingly and willfully failing to obey lawfully commands, F.S.S 810.02(3) burglary to a residence to wit; by entering a structure and/or curtilage thereof and remaining in this spot in order to hide from law enforcement and F.S.S 856.021 Loitering and Prowling to wit; by fleeing onto several resident's private property and concealing himself upon site of law enforcement. This incident occurred in Okaloosa County where I
