On September 20, 2016, Deputy Sheriffs of the Okaloosa County Sherif's Office responded to 1607 Hunt Club Street in Fort Walton Beach, Florida, where it was discovered the victim, Aaron Rodriguez had been stabbed in his lower right abdomen, sustained a large cut on his left arm, and had redness and swelling to his neck.

Subsequent investigation by investigators revealed that Rodriguez and the Defendant, Lequalisha Markee Lewis, have been involved in a dispute over \$180.00 owed to Lewis by Rodriguez for four and half grams of cocaine. Rodriguez advised that during the evening/morning hours prior to this incident, Lewis had been contacting him by telephone attempting to collect the money owed.

On the morning of this incident, Rodriguez was riding his bicycle to his girlfriend's residence during which time he noticed a red in color Dodge Magnum or similar product, following behind him. Rodriguez recognized this vehicle as one Lewis frequently rides in while in engaging in narcotics transactions.

Rodriguez arrived at the Heather Glenn Apartments, where he secured his bicycle to a bicycle rack. While this was occurring, the red in color vehicle pulled into a parking space. Rodriguez began running towards his girlfriend's residence, at which time Lewis emerged from the passenger side of the vehicle and began running after him, armed with a knife. Lewis intercepted Rodriguez and pulled him to the ground. During the course of this struggle, Rodriguez sustained a cut to his left arm and was subsequently stabbed in the lower right abdomen. Lewis got on top of Rodriguez, placed the knife against Rodriguez's neck with enough force to cause redness and swelling to the skin, and informed Rodriguez something to the effect of this being how it would be handled on the streets. Rodriguez was able to push Lewis off of him and run to his girlfriend's residence. Lewis fled the area.

Rodriguez was transported to the Fort Walton Beach Medical Center for medical treatment. During this time, Rodriguez positively identified Lewis as the individual who caused him to sustain the injuries. Additionally, Rodriguez advised that he was in fear of his life based upon the actions of Lewis.

Attempts to locate Lewis for an interview have met with negative results.

This is in violation of F.S.S. 784.045(1a2) Aggravated Battery With A Deadly Weapon and F.S.S. 784.021(1b) Aggravated Assault With Intent To Commit A Felony, and did occur in Okaloosa County, Florida.
