[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Your affiant has reason to believe and does believe the Defendant/D'Aaron Chance Taylor did commit the offense of Battery on a school employee in violation of F.S.S. 784.081(2c) to wit:

1. On 23 September 2016, Defendant/D'Aaron Chance Taylor did deliberately attack a school official with a closed fist and, did willfully and wantonly strike said official in the back/shoulder area. Taylor intended to strike this official about the face, however, missed due to the official's dodging maneuver.
2. Victim/Steven Ray Burke is an employee of the Okaloosa Academy Charter School which is located at 720 Lovejoy Road in the city limits of Fort Walton Beach, Okaloosa County, Florida. Burke did author a sworn, written affidavit of complaint.
3. Search incident to arrest, Chance was found to be in possession of two Alprazolam tablets (Xanax). Alprazolam is a scheduled IV controlled substance.

Based on the facts of this incident, Defendant/D'Aaron Chance Taylor did deliberately strike a school employee with the intent to do harm. Likewise, the Defendant was found to be in possession of a schedule IV controlled substance. These events occurred within Okaloosa County, Florida and are contrary to the law, which are against the peace and dignity of the State of Florida.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On the afternoon of 07/12/2016, victim Danieal Dubose of 5612 North Brooke Drive in the Brooke Estates subdivision of Crestview, Florida reported her vehicle (Florida Tag: 1191CJ) had been burglarized sometime between the late hours of 07/11/2016 and early hours of 07/12/2016. She reported her Springfield extended magazine containing ten .40 caliber rounds and two cans of Grizzly chewing tobacco were stolen from the center console of her vehicle.

Later that evening on 07/12/2016, a stolen pickup truck (OCSO16OFF008726) was recovered unoccupied on Painter Branch Road in Crestview, Florida. It is to be noted, I recovered the vehicle and found it to be out of gas and secured when I arrived. Among the items recovered inside the truck included the Springfield extended magazine, ten .40 caliber rounds, and two cans of Grizzly chewing tobacco, a multi colored pair of men's size 11 shoes, khakis pants, a black tee shirt, and a backpack containing multiple items.

In the course of my investigation, I learned Daaron Chance Taylor was arrested for stealing the aforementioned truck. Taylor admitted post-Miranda that he burglarized several vehicles in the Brooke Estates subdivision in the early morning hours of 07/12/2016 just before he stole the truck. He could not recall all he had taken in Brooke Estates, however, did admit the multi colored size 11 shoes, the khakis, black tee shirt, and backpack were his. Taylor advised he was returning to the truck with gas the night it was recovered when he saw deputies around the vehicle. At that point, he abandoned his plight to return to the vehicle. He also mentioned he acted alone during the burglaries in Brooke Estates and while he stealing the truck.

Based on the totality of circumstances, I have probable cause to believe and do believe Daaron Chance Taylor violated Florida State Statute 810.02(4) in that he willfully, knowingly, and unlawfully burglarized a vehicle belonging to Danieal Dubose. Taylor further violated Florida State Statute 812.014(3a) in that he did willfully, knowingly, and unlawfully take a Springfield extended magazine, ten rounds of .40 caliber ammunition, and two cans of Grizzly tobacco from Danieal Dubose with the intent to permanently deprive her of her property valued at \$60.00. These offenses occurred in Okaloosa County where I am a sworn law enforcement officer.
