[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 10/09/2016 the defendant, KENDALL BRYCE MCFARLAND, did commit the offenses of aggravated assault with a deadly weapon and carrying a concealed firearm pursuant to F.S.S. 784.021(1)(a) and F.S.S. 790.01(2) respectively. These offenses occurred on the Marler Bridge, Destin, Florida 32541.

Per sworn affidavit of complaint the VICTIMS, Justen Dipsch and Lauren Helton, provided the following: While traveling in the left lane on the Marler Bridge, DEFENDANT drove close the their rear bumper. DEFENDANT drove around them to the right hand lane and pulled next to them in a silver Chevrolet HHR bearing KY 217TEH. Hand motions were exchanged between the two drivers. DEFENDANT grabbed a silver and purple firearm out of the dash console. He displayed the firearm in VICTIM'S sight and pulled the slide back. VICTIM said DEFENDANT "pointed it out of the window at us". Both VICTIMS had a well-founded fear violence was about to take place so they sped up and called 911.

DEFENDANT'S vehicle was located in the area of Gulf Shore Drive and Moreno Point Road. A traffic stop was conducted. DEFENDANT was in the driver seat. While detaining another passenger, DEFENDANT spontaneously

uttered, "there is a gun in the car," then he further said, "there is a gun under the front seat".

A show up was conducted and VICTIM said " 100% " as he identified DEFENDANT.

Two of the passengers in DEFENDANT'S vehicle, Chrislyn Decker and David Weiland, corroborated the above incident, however they both said DEFENDANT only displayed the firearm while pulling the slide back.

Post Miranda, DEFENDANT said the actions of VICTIM "pissed me off". He also said VICTIM made a hand motion like shooting a gun however he was "pretty sure he didn't have a gun". DEFENDANT admitted to displaying the firearm but did not say he pointed it at VICTIMS.

DEFENDANT does not have a concealed carry permit.

A silver and purple Taurus 9mm firearm was located under the front seat, with ammunition in the magazine, without a holster.

These offenses occurred in Okaloosa County where I am a sworn law enforcement officer.
