[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 10/23/2016 at approximately 1851 hours, at 1300 E. John Sims Pkwy (Walmart), Niceville, Florida the Defendant, Jon White, committed the offenses of Battery on a LEO and Resistance with Violence to wit:

On the above date and time I was at the above location after information was obtained the Defendant, who was a suspect for multiple felonies in multiple jurisdictions and considered armed and dangerous, had been dropped off approximately 30 minutes prior to my arrival.

The Defendant was located by Deputy David Cain in an aisle near the Garden Center of the store. Deputy Cain asked the Defendant if he had identification. The Defendant told Deputy Cain it was in his truck and had him follow him down the aisle. I met them at the opposite end of the aisle. When the Defendant was approximately ten feet away he looked up at me. I immediately and positively identified him as Jon White.

The Defendant then used his large and heavy stature to force his way past me. After I gave a verbal command to stop, the

Defendant did not comply and continued in my direction. He then struck me in my left chest and shoulder with his left arm and shoulder which pushed me to the side out of his way.

The Defendant continued running through the store and ignored commands by law enforcement to stop. The Defendant continued north thru the store then ran out of an emergency exit towards a wooded area. After he entered the wooded area he lit a fire to evade arrest.

The Defendant was a suspect for multiple felonies in multiple jurisdictions from and was considered armed with a handgun.

The Defendant, Jon White, is charged with one count of Battery on a Law Enforcement Officer pursuant to F.S.S. 784.07.2b and Resisting Arrest with Violence pursuant to F.S.S. 843.01. This offense occurred in Okaloosa County Florida where your Affiant is a sworn law enforcement officer.
