[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On October 25, 2016, at approximately 1718 hours, I responded to 5331 Vernon Taylor Road, Baker, Florida, in reference to a domestic disturbance. Upon arrival, Okaloosa EMS was assisting one of the victims onto a stretcher and later transported her to the North Okaloosa Medical Center.

I then made contact with the other victim, [REDACTED] (66), who explained what happened. [REDACTED] said as she was at [REDACTED] residence helping her, an argument ensued with the defendant, Shanna Gerogiann Burnett. [REDACTED] identified herself as [REDACTED]. The defendant exited her bedroom and began yelling at [REDACTED] and [REDACTED] mother, Marilyn Jinright (64). The defendant got angry during the argument over a statement that was made and struck [REDACTED] on the left side of her face. The defendant then grabbed [REDACTED] by the arm, as she was attempting to call 911, and threw the phone across the residence causing the phone to be disabled. Physical injuries on [REDACTED] were consistent with her statement.

As the defendant was engaged in a physical altercation with [REDACTED] Jinright approached them on her walker and stood up telling the defendant to stop and leave [REDACTED] alone. The defendant then told her mother that she needed to shut her mouth or she would get it next. The defendant then separated from [REDACTED] and grabbed her mother by the neck and slung her to the ground, causing Jinright to fall down onto her right side. It was later determined at the hospital that Jinright

suffered from a non displaced femoral neck fracture to her right leg from being thrown to the ground by the defendant. Jinright also suffered from superficial injuries on her neck where she was grabbed by the defendant.

The defendant departed the residence prior to law enforcement arrival. The defendant is the daughter of Jinright and they reside together in the same residence as a family unit. The defendant was identified as XXXXXXXXXX

The defendant committed the unlawful offenses of Battery On Persons 65 Years Of Age Or Older, in violation of F.S.S. 784.08 (2)(c); and DOMV Felony Battery, in violation of F.S.S. 784.041 (1).

These offenses occurred in Baker, Okaloosa County, Florida, where I am a certified law enforcement officer.
