Affiant has worked exclusively on narcotics related investigations since May 2012. Your Affiant has previously served as a sworn federal Task Force Officer (TFO) with the Drug Enforcement Administration (DEA). Your Affiant being duly sworn states as follows:

Between the dates of 10-26-2016 and 10-27-2016 your Affiant, acting in an undercover capacity, arranged for the purchase of a specific amount of methamphetamine from Eddie BLALOCK. This drug transaction was arranged with BLALOCK via telephonic communication at telephone number 850- [REDACTED]. During the negotiations, your Affiant was contacted by Robert MARKS via telephone number 850- [REDACTED]. During the telephone conversation, MARKS eluded to the fact that he was a conspirator involved in the distribution of methamphetamine with BLALOCK.

Your Affiant subsequently arranged to meet BLALOCK at 701 Harbor Boulevard, Destin, Okaloosa County, Florida, to conduct the drug transaction. Law enforcement surveillance was established in the area of 701 Harbor Boulevard and during this surveillance BLALOCK and MARKS were observed arriving at the arranged meet location in a Toyota truck bearing Florida registration 3290GZ. BLALOCK was observed exiting the back passenger seat of the Toyota and the driver, subsequently identified as Jaymie GREEK, was observed exiting the Toyota as well. It should be noted BLALOCK contacted your Affiant as the group arrived in the Toyota to advise he was at the arranged meet location.

After BLALOCK and GREEK exited the Toyota, law enforcement agents approached the Toyota and detained MARKS along with a juvenile passenger. Law enforcement agents subsequently detained GREEK and BLALOCK as they were returning to the Toyota.

During a search incident to arrest, BLALOCK was found to be possession of approximately five (5) grams of suspected methamphetamine which field tested positive for the presence of methamphetamine. BLALOCK was found to be in possession of the cellular telephone with assigned telephone number 850- [REDACTED]. BLALOCK did have an active warrant for his arrest unrelated to this incident.

While being detained, MARKS was found to be in possession of approximately five (5) grams of suspected methamphetamine which field tested positive for the presence of methamphetamine. Sergeant Jeremy Gilbert observed MARKS holding the aforementioned methamphetamine while he (Sergeant Gilbert) approached the vehicle. During a search incident to arrest, MARKS was found to be in possession of approximately one (1) gram of suspected methamphetamine which field tested positive for the presence of methamphetamine. This methamphetamine was located in his pants pocket. A cellular device with assigned telephone number 850- [REDACTED] was located inside the Toyota and MARKS claimed ownership of this cellular device. MARKS did have an active warrant for his arrest unrelated to this incident.

While detaining GREEK he was found to be in possession of a loaded (no round was chambered) Taurus .40 semi-automatic handgun. It was determined, via criminal history check, that GREEK is a convicted felon and cannot be in possession of a firearm and/or ammunition. It was determined via post Miranda interview with BLALOCK, that GREEK was present for protection during the drug transaction.

During a search of the Toyota, two digital scales were located and subsequently field tested positive for the presence of methamphetamine.

Based on the above your Affiant has probable cause to believe that Robert MARKS III did violate Florida State Statutes 893.13.1a2: Possession of Methamphetamine with Intent to Distribute; 934.215: Use of a Two Way Communication Device to Facilitate a Felony; and 893.147.1: Possession of Drug Paraphernalia. These offenses did occur in Okaloosa County, Florida.
