Warrants Unit conducted a warrant service at 560 W James Lee Boulevard Unit #141, Crestview, Okaloosa County, Florida.

The Okaloosa County Sheriff's Office currently held active felony warrants for the DEFENDANT/Richard Benjamin JONES for the offense of Dealing in Stolen Property (Organized). Information was obtained that the DEFENDANT was residing at the aforementioned residence with his girlfriend/Jennifer HALL, who also had active felony warrants for her arrest.

Investigator Milonas confirmed with the apartment manager that the DEFENDANT and HALL were registered to the aforementioned apartment. Investigator Milonas knocked on the front door and heard a female's voice answer "who is it." Investigator Milonas then loudly stated "Sheriff's Office, open the door." A few moments later, a female opened the door where Investigator Milonas immediately recognized as HALL. As Investigator Milonas was about to detain HALL, Investigator Milonas observed the DEFENDANT through the back kitchen window of the apartment attempting to flee. Investigator Milonas also observed this window to be slightly ajar.

Investigator Milonas called out to perimeter units that the DEFENDANT had fled out the back of the residence and was attempting to flee. The DEFENDANT was observed climbing a fence behind the apartment while patrol units in full Okaloosa County Sheriff's Office uniform were calling out to the DEFENDANT to stop. The DEFENDANT was able to scale the fence where he was challenged by Okaloosa County Sheriff's Office K-9 Deputy Zach Putnam and his K-9 partner Titan. The DEFENDANT did not immediately comply with K-9 Deputy Putnam's commands until the DEFENDANT was advised that a K-9 would be sent to apprehend him. The DEFENDANT was then taken into custody without further incident.

Based on the information provided, Investigator Milonas has reason to believe and does believe Richard Benjamin JONES did commit the offense of resisting an officer without violence. This offense is in violation of F.S.S. 843.02. This offense did occur in Okaloosa County, Florida.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On September 11, 2016, at approximately 0130 hrs, Deputies of Okaloosa County Sheriff's Office (OCSO) responded to the area of Boulevard de la Orleans and surrounding neighborhood in Mary Esther, FL regarding a vehicle burglary with a suspect in the area. During a neighborhood canvass a victim, Michael Crawford, was identified at 307 W. Danielle Court, after law enforcement officers found his vehicle having been burglarized. A pair of silver Costadel Mar, Corbina sunglasses with a value of \$200 was among the items taken. No less than five additional burglaries were reported having occurred in the same area during the same time frame.

On September 12, 2016, the defendant Jennifer Marie HALL sold a pair of silver Costa del Mar, Corbina sunglasses at Anything Pawn and Auction. In the video surveillance provided by the business HALL is seen entering the store with her boyfriend, defendant Richard Benjamin JONES. Each defendant can be positively identified by way of the video and the defendants can be clearly observed working in concert as JONES is initially carrying the property to be sold in a

backpack before turning the property over to HALL to conduct the transaction. JONES can be seen present and participating in the transaction. On September 19, 2016 these sunglasses were positively identified by Michael Crawford as the same which had been stolen on September 11th. Crawford identified these glasses through distinctive blemishes and features which he described as unique to his property.

In addition to the aforementioned Corbina sunglasses, HALL and JONES sold two other pair of sunglasses during the same transaction. These were a pair of Costa del Mar, Jose Jo 10, and Costa del Mar, Hammerhead HH11. All three of these sunglasses are routinely valued at approximately \$200 apiece and were sold by HALL and JONES for \$25 each, a price substantially below the fair market value.

HALL signed and affixed her thumbprint upon the Florida Secondhand Dealer's Property Form which reads: "The seller represents and warrants that the sold property is not stolen... Seller also attests to be the rightful owner of the sold property, that Seller has the right to sell the property... If proven otherwise Seller understands that Seller will be criminally prosecuted to the fullest extent of the law."

JONES has been identified as a suspect in no less than six strings of burglaries occurring in Santa Rosa, Okaloosa, and Walton Counties over the span of three months and warrants are forthcoming. In addition HALL has been documented as having sold or pawned 53 items within the last six months, 25 of which in the last three months have been sunglasses.

Based on the above probable cause the affiant has reason to believe and does believe that the defendants, Jennifer Marie HALL and Richard Benjamin JONES have committed or are principal to the offenses of Dealing in Stolen Property (organized). Additionally HALL has committed the offense of Providing False Declaration of Ownership to a Pawnbroker. These offenses are in violation of Florida State Statutes 812.019(2) and 539.001(8.b.8.a) respectively and occurred in Okaloosa County, FL.
