[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 10/25/2016, at approximately 2235 hours, I attempted a traffic stop on a white Nissan SUV, bearing FL tag# Y76DEC, due to the vehicle's registration expiring on 12/31/2015.

I initiated my emergency lights, on my OCSO marked patrol vehicle, as the vehicle turned onto Palmetto Dr, from Miracle Strip Parkway, Mary Esther, FL. Upon doing so, the suspect vehicle failed to stop and began to accelerate away at a high rate of speed down Palmetto Dr. I initiated my siren and began to pursue. The suspect vehicle ran several posted stop sign's, before turning West on Hollywood Blvd. While pursuing the vehicle west on Hollywood, the suspect vehicle ran a solid red light at the intersecting roadway of Mary Esther Blvd, at estimated speeds of approximately 60MPH, traveling West on Hollywood Blvd. As the vehicle went through the listed intersection it almost lost control, weaving between three lanes, before it came back under control. I proceed through the intersection and reached speeds of approximately 80MPH, pursuing the vehicle but it was still pulling away, gaining distance. Contact was later lost.

A short time later the vehicle was located in a wooded area off Hollywood Blvd, approximately 75 yards in the wood-line from the roadway, turned on it's roof. No one was with the vehicle. I located a male, identified as the witness, Brian Lanieux, who admitted to being the passenger in the vehicle when it fled. He advised a male he only knew by Joe was driving. He said when I initiated the stop Joe began to flee. He told Joe to let him out but Joe told him he, "had to go" continuing to flee. The witness later provided a Facebook photo of Joe, which matched an ID belonging to, Joseph Fletcher, found in the suspect vehicle. The witness confirmed the defendant as the driver of the vehicle when it fled. The witness later showed me a text message he received from defendant's girlfriend. The message was asking him if he was ok, due to the defendant being in a chase.

I made contact with the defendant's girlfriend via telephone. She advised she was on the phone with the defendant when he began to flee from law enforcement and that is how she knew of the incident.

A deputy made contact made with the Registered Owner of the vehicle, identified as the victim, Kristina Spent-Bell, who provided an affidavit of complainant. She stated her vehicle had been stolen. Kristina stated the last time she saw the vehicle was at an acquaintances home, approximately three weeks ago, on 1826 Pointed Leaf Lane, Fort Walton Beach, Florida. Kristina valued the car at \$10,000, which was a 2006 Nissan Xterra 4 door SUV, bearing FL tag of Y76DEC, VIN # 5N1AN08U16C544474.

I later located the defendant at 180 Mary Esther Blvd, Mary Esther, FL, who had an injury to his ear. In a post Miranda interview, I asked the defendant why he ran from me. The defendant advised because of his license, he was out on bond, there was a gun in the car, and drugs in the car. I asked the defendant how long his license had been suspended, he stated he doesn't remember ever having a license. I asked him where he got the white Nissan Extara from. The defendant advised he got it from a lady who said she was tired of having it in her yard. He said he traded two grams of, "ice" and \$80.00, for it. I asked him if he knew the vehicle was stolen. The suspect said he did not know it was stolen until the other day. He said he replaced the ignition in it. I asked him if that was another reason he ran, because the vehicle was stolen, and he advised, "I mean you can take your pick."

The defendant admitted to having a syringe in his pocket. Another deputy asked the suspect again if he had

anything on him. The defendant advised he may have, "pot" also know as Marijuana. Upon conducting a search of the defendant's person, the deputy located two small bags containing less than a gram of a white crystal like substance believed to be Methamphetamine in his shirt pocket, and a needle in his shorts pocket.

The suspected methamphetamine tested presumptive positive for Methamphetamine.

Based on the evidence I have reason to and do believe the defendant, Joseph Fletcher, was in violation of F.S.S. 316.1935.3a Fleeing With Disregard To Safety, F.S.S. 812.014.2c6 Vehicle Theft, and F.S.S. 893.13.6a Possession of Controlled Substance. This incident occurred in Okaloosa County, FL.
