[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Wednesday, November 2, 2016, Investigators with the Okaloosa County Sheriff's Office Special Investigations Section conducted a consensual encounter with the occupants at 4624 Scarlet Drive East in Crestview, Okaloosa County, Florida. Investigators Casey Dennis and Dennis Fields identified Jacy Dane McCuiston, Ashley Dawn Varnum, and Kaylie Dawn Judy as the occupants of this residence during this encounter. Investigators developed probable cause and obtained a search warrant for this residence.

In the course of the search warrant, Investigators recovered approximately 77 grams of methamphetamine, approximately 45 grams (total package weight) of marijuana, approximately 22 dosage units of Hydrocodone, scales, syringes, pipes, and plastic jeweler's bags. These items were discovered in the bedroom utilized by McCuiston. Among the items recovered, approximately one gram of marijuana was packaged inside a small plastic jeweler's bag; three plastic jeweler's bags contained multiple doses of Hydrocodone; and five plastic jeweler's bags contained methamphetamine. I recognized the manner in which the narcotics were packaged as consistent with the distribution of controlled substances. Additionally, Investigators discovered \$2250.00 in US Currency, with denominations ranging from \$1.00 to \$20.00. The cash was found bundled and bound by a single blue rubber band and in the safe with the the narcotics. Documents inside the safe identified the owner as McCuiston. Additionally, McCuiston was in possession of the key to the safe. Post MIRANDA< McCuiston declined to make a statement.

In the bedroom occupied by Ashley Varnum and the homeowner (Johnathan Roche), Investigators recovered a blue colored palstic jeweler's bag containing seven dosage units of Alprazolam and three dosage units of Clonazepam. Varnum stated post MIRANDA she does not have a prescription for these controlled substances. These items were found on top of the dresser identified by Varnum as the dresser she uses in the residence. This was verified by her clothing found inside the drawers.

At the Okaloosa County Jail, McCuiston was found in possession of a partial pill marked "P" and "3" by Okaloosa County Jail staff. I tenatively identified the substance as Hydromorphone (Dilaudid). In the course of my investigation, I learned McCuiston is currently on felony probation and has been since March 30, 2015. It is to be noted, the address of 4624 Scarlet Drive East is within 1000 feet of the Live Oak Baptist Church located at 4565 Live Oak Church Rd, Crestview, Florida.

Based on a totality of the circumstances, I have probable cause to believe and do believe Jacy Dane McCuiston violated Florida State Statute 893.135(1f1) in that he was willingly, knowingly, and feloniously in possession of approximately 77 grams of methamphetamine. I have probable cause to believe Jacy Dane McCuiston violated Florida State Statute 893.13(1e2) on two separate counts in that he did willingly, knowingly, and unlawfully possess marijuana and hydrocodone with the intent to distribute while within 1000 feet of the Live Oak Baptisr Church. I have probable cause to believe Jacy Dane McCuiston violated Florida State STatute 893.147 in that he did willingly, knowingly, and unlawfully possess paraphernalia to package, ingest, and store controlled substances. I have probable cause to believe Jacy Dane McCuiston violated Florida State Statute 944.47 in that he did willfully and knowingly possess and bring into the Okaloosa County Jail a controlled substance, to wit: hydromorphone. I have probable cause to believe and do believe Jacy Dane McCuiston did violate Florida State Statute 948.06(a) in that he was found to be in possession of controlled substances while on supervised probation.

These offenses occurred in Okaloosa County where I am a sworn law enforcement officer
