[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Monday, December 05, 2016 the DEFENDANT, Amber Koestler, did commit Battery on the VICTIM, Malina Gabriel by pushing, kicking, and striking the VICTIM during an altercation.

The DEFENDANT and the VICTIM initially got into a physical altercation after the DEFENDANT returned

home after driving with the VICTIM'S ex-girlfriend. The VICTIM was awoken by the DEFENDANT and ex-girlfriend. The DEFENDANT was heavily intoxicated and struck the VICTIM and left the room. Afterwards, the VICTIM shut the bedroom door and locked it in order to keep the DEFENDANT away. The DEFENDANT began to pounding on the door, breaking a hole in the door. The DEFENDANT repeatedly screamed, " I hope you die", and " I love your ex."

During attempt to arrest, the DEFENDANT was very resistant and combative, having to be dragged outside. Upon trying to get her into the vehicle, law enforcement had to physical place her inside the vehicle. While maneuvering the vehicle to depart en route to booking facility, the DEFENDANT got out of her handcuffs and began to punch and kick the door and inside the vehicle. When deputies opened the door to restrain her, the DEFENDANT grabbed the handcuff's and postured her body, leading law enforcement to believe she was going to use them as a weapon. The DEFENDANT was subsequently tased once. Taser was ineffective due to the probes only going into the DEFENDANT's pant legs and they had negative contact. Handcuffs were then reapplied and subject was transported to Okaloosa Booking Facility without incident.

While the DEFENDANT was in the Okaloosa Booking Facility, the DEFENDANT smuggled a lighter inside the facility. While locked in her cell, she yet again maneuvered out of her handcuffs and set fire to her cell using the toilet paper roll provided. Once deputies smelled the odor of smoke they began to evacuate the prisoners, at which time they discovered the incident.

The DEFENDANT was previously convicted of Battery on June 02, 2004 in Escambia County, Florida.

Based on my investigations, and statements provided, I have reason to believe and do believe the DEFENDANT, Amber Koestler, did violate F.S.S. 784.03.2 Battery DOMV Touch or Strike 2nd or subsequent offense, 843.02 Resisting Officer without Violence, and 806.01B Arson. This incident occurred in Okaloosa County, Florida, where I am a sworn Law Enforcement Officer.
