[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On December 30, 2016, the defendant Derrick Washington (DOB 11/23/92) did violate F.S.S. 812.135 Home Invasion Robbery (Armed), F.S.S. 784.045(1)A(2) Aggravated Battery with a deadly weapon F.S.S. 790.07(4) Possession of a firearm during the commission of a felony and F.S.S. 812.014(2)C Grand Theft. On the above date, I responded to Motel 6 located at 405 Harbor Blvd Destin, Okaloosa County FL 32541 in reference to a robbery. The defendant and co-defendant, Daniel Burns entered Room #158. The defendant pulled a "High Point 9MM" and ordered everyone to the ground and to give them the money. In the process the Defendant struck one victim, Brian Lanieux in the head with the handgun. During the robbery the defendant ordered Lanieux to strip to his underwear and to go into the bathroom where he was held at gun point. During the Robbery the defendant stole \$600 cash, gold money clip and a gold necklace from Lanieux and stole \$30 from a second victim, Nicholas Carasso. In the process of battering both victims, Carasso pulled a knife in an effort to protect himself. When Carasso pulled his knife he struggled with the defendant and received a superficial cut to his finger. The defendant and Burns fled the scene in a white in color Lexus IS.

Investigation led us to 102 Eccles Rd Fort Walton Beach where the defendant was detained. Both victims conducted a show up and positively identified the defendant. The defendant was arrested and transported to booking without incident. Post Miranda Warning the defendant admitted to being at the hotel but denied robbing anyone.

These offenses occurred within Okaloosa County Florida, where I am a sworn law enforcement officer.
