[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

During the time frame of June, 21, 2016 and November 21, 2016 your Affiant was working in an undercover capacity attempting to identify persons using Bit Torrent peer to peer software on the Internet to traffic and/or distribute images of child pornography. During this time frame Your Affiant successfully downloaded files which contained child pornography from an individual utilizing the IP address of [REDACTED]

On November 11, 2016, a subpoena was issued by the State Attorney's Office of the First Judicial Circuit in reference to the Internet service provider Valparaiso Broadband Communication Systems (VBCS), which is controlled by the City of Valparaiso who leases the IP addresses to its customers. Valparaiso Broadband Communication Systems [VBCS is the Internet Service Provider for the IP address [REDACTED]]. I requested the account holder and associated information for the IP address [REDACTED] that was observed between August 11, 2016 and October 31, 2016.

On November 15, 2016, James Butler, General Manager of Valparaiso Broadband Communications Systems responded to the subpoena service for IP address [REDACTED]. Per the subpoena return the IP address [REDACTED] was leased

During the Investigation Your Affiant reviewed the downloaded images and pictures. During in the initial computer investigation of the Bit Torrent peer-to-peer program using IP address [REDACTED], the client program reported that the computer located at [REDACTED] with the geographical address of 68 WOLVERINE AVE Valparaiso, FL 32580. The following is a representation of some of the files which were being distributed:

Torrent info hash: [REDACTED] (downloaded August 11, 2016)

This Torrent info hash reported it possessed one video file which comprised of 268 pieces. The computer at the IP address [REDACTED] reported it had all 268 pieces of the Torrent file. Your Affiant has viewed the downloaded file from this info hash and knows that these files represent child sexual abuse. Below is a description of some of the file the computer at IP address [REDACTED] was making available:

Video file name custom Inna Model masturbating.wmv
Video length: 53 seconds

Video description: The video is of a prepubescent female between the approximate ages of seven (7) and nine (9) years old. The juvenile female is naked from the waist down and is seen masturbating. The focus of the video is the juvenile female vagina.

Torrent info hash: [REDACTED] (downloaded August 15, 2016)

This Torrent info hash reported it possessed sixty-three (63) files which comprised of 482 pieces. The computer at the IP address [REDACTED] reported it had 171 pieces of the 482 piece Torrent file. Your Affiant has viewed the downloaded file from this info hash and knows that these files represent child sexual abuse. Below is a description of some of the file the computer at IP address [REDACTED] was making available:

On November 29, 2016, the Honorable Judge Flowers signed a search warrant for 68 Wolverine Ave. On November 30, 2016 the search warrant was executed. Robert Scroggins was not on scene when the search warrant was executed. On December 1, 2016 Scroggins called your Affiant and requested to speak at the Okaloosa County Sheriff's Office.

On December 2, 2016, Robert Scroggins came to the Okaloosa County Sheriff's Office of his own free will for an interview.

On December 2, 2016, your Affiant interviewed Robert Scroggins in the Investigations interview room located at 50 2nd Ave, Shalimar Florida.

On December 2, 2016, your Affiant advised Scroggins of his Miranda Warning from the Okaloosa County Sheriff's Office Your Rights Form. Scroggins signed the form stating he understood his rights and again signed the form stating he wished to speak to me without a lawyer present. Scroggins admitted to the following:

- Scroggins admitted the computer in Room C was his computer and that he was the primary user of the computer.
- Scroggins admitted to installing the UTorrent peer to peer program on the computer.
- Scroggins admitted he used the user profile "z" to download child pornography.
- Scroggins admitted he would download the file view them and delete them.
- Scroggins stated he never touched [REDACTED] which was verified in the discovery interview with the child.

The computer which was seized from Room C was forensically processed. There were 128 documented images and videos of child sexual abuse; there were 21, 713 documented images and videos of child erotica and 180 images and videos of anime which depicted child sexual abuse. The following is a representation of the image of child sexual abuse which were

Description: The video starts with a prepubescent juvenile female between the approximate ages on eight (8) and ten (10) years old. In the video an adult male is seen digitally penetrating the juvenile female's vagina and anus. At the twenty-four (24) minute nine (9) second mark in the video the video changes to a different video which has two prepubescent juvenile females between the approximate ages of eight (8) and ten (10) years old. In the video an adult male is seen fondling the females. Later in the video adult male is seen attempting to force one of the juvenile females to perform oral sex on him.

This incident occurred in Okaloosa County Florida where your Affiant is a sworn Law Enforcement Officer.
