Between the dates of December 14, 2016 and December 28, 2016 the defendant, Brandon Michael Zick, did commit the criminal offenses of Armed Burglary to an Unoccupied Dwelling, Grand Theft of Property Valued Between \$20,000 and \$100,000, Criminal Mischief Damage Over \$1,000 & Grand Theft of a Firearm (53 Counts).

During the above mentioned timeframe the defendant and co-defendant, Joshua Rex Zick, unlawfully and without permission entered the victim's unoccupied residence located at [redacted] Bear Head Road, Crestview, Florida. After forcing entry into the backdoor of the residence, both the defendant and co-defendant located a 600 pound Liberty Gun Safe that was stored inside one of the spare bedrooms. This safe was in the locked position and housed 53 firearms valued at approximately \$22,927, a large amount of gold & silver women's jewelry valued at approximately \$15,000 & silver bars and coins valued at approximately \$5,000. The defendant and co-defendant utilized a dolly hand truck that they brought with them to move the safe from the residence to the bed of the defendant's truck that was parked outside the front door. After loading the safe, the defendant and co-defendant drove to the Anderson Columbia Plant located at 1301 U.S. Highway 90, Holt, Florida where they both utilized crowbars and a chop saw to force entry into the stolen safe. Once inside, the defendant and co-defendant removed all 53 firearms and the other above listed contents from within. The defendant then utilized a tractor from Anderson Columbia and buried the completely destroyed safe on that property.

On January 17, 2017 I conducted recorded interviews with the defendant and co-defendant where I advised them both of their Miranda protection. They both advised that they understood their rights and agreed to speak with me about this case. During the interviews, the defendant and co-defendant both confessed to the above mentioned facts. The co-defendant told me that all of the stolen guns were inside his Chevy truck, a lock box in the backyard, and in the closet of his master bedroom. With the consent of the co-defendant, all of the guns were located and recovered from those specified areas. The defendant then turned over all of the stolen jewelry, silver coins & silver bars that were stolen from within the safe.

These offenses did occur in Okaloosa County where I am a sworn law Enforcement Officer.
