[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 02/14/2017, the DEFENDANT, Treyvon Darelle Cannon-Riggs committed the offense of obstructing justice pursuant to F.S.S. 843.02. This offense occurred in the area of Whispering Oaks Lane, Fort Walton Beach, Florida.

I attempted to conduct a warrant service with the DEFENDANT outside of 1855 Whispering Oaks Lane. I had previous knowledge the DEFENDANT had two active felony warrants out of this agency. DEFENDANT was observed walking a dog along a trail next to this residence. In full Okaloosa County Sheriff's Office uniform, I called for

DEFENDANT to come back. The DEFENDANT looked back and continued walking. Upon our approach to the DEFENDANT, he jumped over a 6 foot wooden fence, leaving his dog behind. The DEFENDANT continued to run west down Oaklawn Drive, through back yards, jumped over another 6 foot wooden fence. A perimeter was set and K9 Unit responded. While on Perimeter, the DEFENDANT, ran behind a patrol vehicle, jumping another 6 foot fence. A home owner at 716 Meadows Court, observed the DEFENDANT and confronted him. Upon my arrival to this location, the DEFENDANT, was held at gun point and given verbal commands which he complied. The DEFENDANT was taken into custody.

DEFENDANT stated he ran because he was scared.

Based off my investigation, I believe and do believe, the DEFENDANT, **Treyvon Darelle Cannon-Riggs**, did willfully violate F.S.S. 843.02 Resisting without violence. This incident occurred in Okaloosa County where I am a Sworn Law Enforcement Officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On February 11, 2017 I responded to 814 Westwood Dr. in reference to a armed disturbance.

The victims stated the defendant, Treyvon Darelle Cannon-Riggs pointed a silver handgun at them and stated "I am going to kill all of you". The victim stated Treyvon was upset due to his grandmother getting on to him about Treyvon's two pit-bulls being at the residence. The victims stated Treyvon began yelling profanities at one of the victims and tried to push a kitchen table on top of her.

One of the victims stated he attempted to calm Treyvon down. The victim stated Treyvon got in his face and then retrieved a silver handgun from his backpack. The victim stated Treyvon struck him in the head with the handgun and they began to fight on the ground.

I observed two quarter sized contusions on the left side of the victims head and swelling to his left shoulder.

The other victims stated they separated the two and Treyvon pointed the handgun at all of them. The victims stated Treyvon pointed the handgun at them while saying, "I am going to kill all of you". The victims completed written statements which they were sworn to.

The witnesses stated they observed Treyvon strike the victim in the head with the handgun. The witnesses stated they observed Treyvon retrieve a handgun from his back pack and point it at the victims. The witnesses stated they heard Treyvon say he was going to kill everyone, while pointing the handgun at them. The witnesses provided recorded statements which they were sworn to.

The victims and Treyvon are all related by blood and range from Granparents, Uncles and Cousins.

A search of Treyvon's criminal history revealed, on 12/15/2014 he was convicted guilty in Okaloosa County, Florida for Aggravated Fleeing and Attempting to Elude LEO With Injury.

Based on my investigation which consisted of interviews with the victims, the witnesses and my observation of physical evidence. I have probable cause to believe and do believe the defendant, Treyvon Darelle Cannon-Riggs violated F.S.S. 784.021(1)(a) Aggravated Assault With a Weapon Without Intent to Kill, F.S.S. 784.045(1)(a)(2) Aggravated Battery With a Deadly Weapon and F.S.S. 790.23(1)(a) Possession of Firearm or Ammo by Convicted Felon. This incident occurred in Okaloosa County, Florida.
