[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

Your affiant has reason to believe the defendant (Donald Jones) committed sexual battery on a child under the age of 12 years old [REDACTED] was in possession of controlled substances (2 counts), and violated his felony probation; to wit,

On January 29, 2017, the Okaloosa County Sheriff's Office took the report of a sexual battery on a four-year-old juvenile victim which occurred on January 20, 2017, in Okaloosa County, Florida. Per the victim's mother's sworn affidavit of complaint and the victim's interview with the Child Protection Team, the following occurred:

On January 20, 2017, during the night, the victim was in her bed [REDACTED] [REDACTED] Crestview, Florida, when [REDACTED] (the defendant) entered her room, laid next to her in bed, removed her pajama bottoms, and rubbed her genital area before inserting his finger into her vagina.

On January 21, 2017, the next morning, the victim's mother observed the victim wearing only her pajama top and panties; which was unusual. When asked, the victim informed her mother [REDACTED] took off my pants, laid in bed with me, took off my pajama bottoms, slipped his hand underneath my panties, played with me down there, and digitally penetrated me.' The victim's mother located the pajama bottoms crumpled into a ball inside the sheets of the victim's bed.

On January 31, 2017, the four-year-old victim was interviewed by the Child Protection Team at the Child Advocacy Center located at 401 McEwen Drive, Niceville, Florida. During the recorded video interview she disclosed her [REDACTED] put his finger in her "butt" when she was in her bed. She used the term butt in reference to her vagina; as she informed the investigator she used her butt to go "pee pee." According to the victim [REDACTED] took off her pajama bottoms, was playing around with her genital area, and then stuck his finger in her vagina. The victim said this occurred one time.

On February 7, 2017, your affiant interviewed the defendant. Post Miranda, the defendant [REDACTED] [REDACTED] victim's mother, and at the time of the sexual battery, [REDACTED] [REDACTED] The defendant denied the allegation of sexual battery and denied using controlled substances. The defendant swore to his oral statement.

Search incident to arrest, the defendant was found in possession of controlled substances (Heroin and Methamphetamine) which both field-tested presumptive positive.

Per your affiant's review of the defendant's criminal history revealed he was a registered sex offender.

Your affiant verified the defendant's felony probation status with his probation officer.

Your affiant has reason to believe and does believe the defendant (Donald Jones) committed sexual battery on a child under the age of 12 years old [REDACTED] contrary to Florida Statute 794.011(8)(c), was in possession of controlled substances (2 Counts), contrary to Florida Statute 893.13(6)(a), and violated his felony probation, contrary to Florida Statute, 948.06(a). These offenses occurred in Okaloosa County, Florida, where your affiant is a sworn law enforcement officer.
