[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 26, 2017, at approximately 2315 Hours, at or about 1007 E US Hwy 98, Destin, FL, the defendant, Charles James Haggart, knowingly and willfully pointed a green beam of a laser lighting device on an individual operating a motor vehicle.

A victim provided the suspect vehicle description and tag number and deputies stopped the vehicle shortly after the incident in Destin. Another complainant advised the laser was pointed at them while driving but did not want contact with law enforcement.

The defendant was found to be in possession of a laser lighting device and spontaneously uttered that it was all him and not the driver/co-defendant, Derrick Cole Taylor.

Post Miranda, the defendant stated it was the co-defendant's laser, however the defendant was shining the laser at street signs from the passenger seat of a moving vehicle.

The victim stated the green laser light was coming from the passenger of the vehicle and it was trained on him even after the victim hit his brakes to let the defendant's vehicle pass. Due to the amount of time the laser light was shined on the victim and his vehicle along with the changing relative positions of the vehicles, he felt certain that he was intentionally targeted. The victim stated the laser light made it very difficult to drive by obstructing his eyesight.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 26, 2017, at approximately 2315 Hours, at or about 1007 E US Hwy 98, Destin, FL, the defendant, Derrick Cole Taylor, knowingly and willfully operated a motor vehicle and allowed a passenger to point a green beam of a laser lighting device on an individual operating a motor vehicle.

A victim provided the suspect vehicle description and tag number and deputies stopped the vehicle shortly after the incident in Destin. Another complainant advised the laser was pointed at them while driving but did not want contact with law enforcement.

The passenger/co-defendant was found to be in possession of a laser lighting device and spontaneously uttered that it was all him and not the driver/defendant, Derrick Cole Taylor.

Post Miranda, the co-defendant stated it was the defendant's laser, however the co-defendant was shining the laser at street signs from the passenger seat of a moving vehicle.

The victim stated the green laser light was coming from the passenger of the vehicle and it was trained on him even after the victim hit his brakes to let the defendant's vehicle pass. Due to the amount of time the laser light was shined on the victim and his vehicle, he felt certain, he was intentionally targeted. The victim stated the laser light made it very difficult to drive by obstructing his eyesight.

Post-Miranda, the defendant initially stated the laser was not his and the first time he saw it was when the passenger

displayed it in the vehicle moments before shining it out of the vehicle. When confronted with the co-defendant's statement about the ownership, the defendant claimed ownership of the laser. The two agreed to lie when stopped by law enforcement. The defendant did not take steps to stop his passenger's unlawful behavior even though the defendant was in control of the vehicle and the laser pointer belonged to him.

Based on the above investigation I believe the defendant, Derrick Cole Taylor, did willfully violate F.S.S. 784.062 Principal to Misuse of laser lighting devices. This offense did occur in Okaloosa where your affiant is a sworn Law Enforcement Officer.
